

# High School Judge Cheat Sheet

This sheet is designed to provide a basic guideline to the criteria that can be used for judging individual **SPEECH** events. Remember, feedback is crucial! <p>In a prep room (not your room), competitors are presented with a choice of three current event questions related to national and international current events. The competitor has 30 minutes to prepare a seven-minute speech answering the selected question. Judges will receive competitors one at a time, in 10-minute increments. Each student should stay to watch the remaining competitors.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: Up to 7 minutes (only valid if timed with stopwatch)</li> <li>• Time violations cannot place first (<b>30 second grace period</b>).</li> <li>• <b>NO NOTES (Paper or Digital)</b></li> <li>• Those using notes should not rank first</li> <li>• Organized, flows, easy-to-follow.</li> <li>• Clear message</li> <li>• Relatable to any audience</li> <li>• Cited evidence to support the cause, problem, and a solution that could mitigate the problem.</li> <li>• Factually accurate</li> <li>• Organized, focused on topic, research referenced.</li> <li>• Judge opinion on the topic should <b>not</b> influence ranking.</li> </ul>	<p>Competitors write, <b>memorize</b>, and deliver a problem/solution speech with the intent to persuade the audience on a topic of significance. It usually has a problem, with causes, effects, and solutions. Competitors should remain in the room for the remaining competitors' speeches.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 10 minutes (only valid if timed with stopwatch)</li> <li>• Time violations cannot place first (<b>30 second grace period</b>).</li> <li>• <b>NO NOTES (Paper or Digital)</b></li> <li>• Those using notes should not rank first</li> <li>• Organized, flows, easy-to-follow.</li> <li>• Clear message</li> <li>• Relatable to any audience</li> <li>• Cited evidence to support the cause, problem, and a solution that could mitigate the problem.</li> </ul>	<p>Competitors <b>memorize</b> and deliver a portion or portions of a printed, published, &amp; publicly delivered speech previously performed by someone else (commencement addresses, historical speeches, political speeches, celebrity speeches, etc.). There will be a brief introduction to the piece near the beginning of the speech.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 10 minutes (only valid if timed with stopwatch)</li> <li>• Time violations cannot place first (<b>30 second grace period</b>).</li> <li>• <b>NO NOTES (Paper or Digital)</b></li> <li>• Those using notes should not rank first</li> <li>• Entertaining, relatable, &amp; flows</li> <li>• Speech choice appropriate for competition</li> </ul>	<p>Students have 7 minutes to prepare <b>and</b> give an improvised speech without notes.</p> <p><u>Draw:</u> (One speaker at a time) The judge has the speaker draw three prompts from an envelope. The speaker will choose one. The 7 minutes will start once the speaker chooses the topic (that topic is no longer valid for any other competitor). Competitors should remain in the room for all speeches.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 7 minutes (only valid if timed with stopwatch)</li> <li>• 7 minutes includes preparation time <b>and</b> giving the speech.</li> <li>• Time violations cannot place first (<b>30 second grace period</b>).</li> <li>• <b>NO NOTES (Paper or Digital)</b></li> <li>• Those using notes should not rank first in the round.</li> <li>• Organized, focused on topic, and supported using examples.</li> </ul>	<p>Competitors cut, <b>memorize</b> and perform their interpretation of a printed published, publicly accessible piece (script, movie, story, novel, etc.) including either single or multiple characters. <b>PROPS ARE NOT PERMITTED</b> (any item is considered a prop: chair, floor, table, etc.). In <b>DUO</b>, competitors may <b>not</b> make eye contact, nor touch. There will be a brief introduction to the piece near the beginning of the piece.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 10 minutes</li> <li>• Time violations cannot place first (<b>30 second grace period</b>).</li> <li>• <b>No scripts/notes</b></li> <li>• Time violations shouldn't rank first</li> <li>• <b>DUO</b> – Students do not touch or have eye contact except during the introduction.</li> </ul> <p><u>Content/Delivery</u></p> <ul style="list-style-type: none"> <li>• Entertaining</li> <li>• Piece should be challenging &amp; appropriate for competition.</li> <li>• Not mimicking the original, but an interpreted message using original wording.</li> <li>• Characters clearly defined and differentiated.</li> </ul>	<p>Students <b>deliver interpretative readings</b> of published prose, poetry, or drama (plays) thematically linked from two or three genres. The contestant must address the script; however, introduction and transitional may be memorized.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 10 minutes</li> <li>• Time violations should not place first (<b>30 second grace period</b>).</li> <li>• Maintains impression of reading from script in <b>black binder</b></li> <li>• Different types of literature should be cut into one cohesive, themed performance.</li> <li>• Characters should be distinguished and unique from each other.</li> <li>• Manuscript book can be used as a prop.</li> <li>• Blocking movements should enhance not distract and convey emotions, motivations, and physical factors.</li> </ul> <p><u>Content &amp; Delivery</u></p> <ul style="list-style-type: none"> <li>• Piece choice challenging and appropriate for competition.</li> <li>• Eye contact &amp; Confident</li> <li>• Volume &amp; speaking rate</li> </ul>	<p>A self-written speech on a topic of their choice, using logic and evidence to inform not advocate. Visual aids are allowed. All research should be cited verbally.</p> <p><u>Judging:</u></p> <ul style="list-style-type: none"> <li>• Time: up to 10 minutes</li> <li>• Time violations should not place first (<b>30 second grace period</b>).</li> <li>• Focused on topic</li> <li>• Organized and factual information with support of sources.</li> <li>• Should educate and entertain</li> <li>• Visual aids are engaging and have smooth delivery</li> </ul> <p><u>Delivery</u></p> <ul style="list-style-type: none"> <li>• Eye contact</li> <li>• Organized, knowledgeable, and informative</li> <li>• Confidence</li> <li>• Smooth delivery</li> </ul>

<p>Contestants in Student Congress become legislators charged with the task of fulfilling the responsibilities of the US legislative branch of the federal government. There is a chamber of 15-18 competitors, as well as a PO (Presiding Officer-will run the room using Parliamentary Procedure)</p> <p><b>Regulations</b></p> <ul style="list-style-type: none"> <li>• Student speeches are up to 3 minutes (PO will announce speech times)</li> <li>• Legislation authors have 2 minutes mandatory questioning period</li> <li>• All other questioning periods are 1 minute.</li> <li>• Students may not have visual aids</li> <li>• Speech should be on appropriate topic/side</li> <li>• Focused on topic, organized, factual accuracy, good composition, references</li> <li>• Eye Contact, confidence, appropriate/professional tone</li> </ul> <p>Score every ballot – points range from 1 (poor) to 6 (excellent).</p> <p>Competitors should not receive extra points for questioning, however it should help determine ranking if the speech points are tied.</p> <p>Your opinion on the topic should <b>not</b> influence the ranking.</p> <p>Competitors rank 1 (best) -8 (look at how many speeches they made, how many points you gave for each speech, their decorum towards the chamber, participation, questioning, etc.)</p> <p>Please make detailed positive and constructive comments on each student ballot.</p>	<p>Team event that advocates or rejects a position posed by the resolution.
