## TS-1 A Bill to Provide Better Equity During Federal Elections

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1. SECTION 1 No result from an election for a federal office may be made public or 2. communicated by the press until all polling locations for that office, regardless of the state, has been closed for a period of one hour. 3. 4. SECTION 2. A. For Presidential elections, "all polling locations" will include those in Alaska 5. and Hawaii. For Congressional elections, polling locations will include those 6. within that state or district. This is exclusive of absentee balloting or provisional 7. ballots. 8. B. "Results" may include exit polling data, official or unofficial "calling" of states 9. prior to official communication from the appropriate state authority, or actual results provided by the appropriate state authority. 10. 11. SECTION 3. The United States Election Assistance Commission shall be responsible for 12. monitoring and enforcing the provisions of this Act. 13. SECTION 4. This will take effect on November 1, 2020. 14. SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

# TS-2 A Bill to Ban Tobacco

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1.	SECTION 1.	Tobacco plants and products shall be banned from sale, production,	
2.		growing, creation, and distribution within the United States and its territories.	
3.	SECTION 2.	Tobacco products are listed here as: chewing tobacco, cigarettes, cigarillos,	
4.		cigars, snus, and snuff. Tobacco shall be defined as the physical tobacco plant	
5.		and its leaves.	
6.	SECTION 3.	The DEA and Department of Justice shall oversee this legislation.	
7.		A. Because tobacco is a commercial product, all persons and businesses,	
8.		must use or dispose of all products within the calendar year of passing this to	
9.		legislation; entities in possession of tobacco and tobacco products would thent	
10.		face criminal prosecution.	
11.		B. Following this legislation, death from tobacco use will be considered a	
12.		homicide,and those who own the product corporation will be charged.	
13.		C. Tobacco shall now be considered a Schedule 1 drug.	
14.	SECTION 4.	This Legislation shall go into effect immediately after passage	
15.	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

# TS-3 A Bill for Presidential Candidates to Release Their Tax Returns to Increase Transparency Among Candidates

### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1.	SECTION 1.	All presidential candidates will be required to publicly release all of their
2.		tax returns for the past 10 fiscal years. They must include all of their taxes
3.		and any of their subsidiaries for the past 10 fiscal years.
4.	SECTION 2.	Tax Return - a form on which a taxpayer makes an annual statement of
5.		income and personal circumstances, used by the Internal Revenue
6.		Service to assess liability for tax
7.		Publicly Release - a written or recorded communication directed at
8.		members of the public. The information must be accessible by the
9.		general public and must not be locked behind a paywall, password,
10.		region, security, etc
11.		Presidential Candidate – Any person who is publicly running for the
12.		presidential office. This includes all persons who are competing in the
13.		presidential primaries.
14.	SECTION 3.	Tax Returns must be released in their entirety by May 31st of that election
15.		year.
16.	SECTION 4.	The Federal Department of Justice (DOJ) will enforce this bill.
17.	SECTION 5,	This bill is to be enacted for the next election cycle upon passage.
18.	SECTION 6,	All laws in conflict with this legislation are hereby declared null and void.

1.	WHEREAS,	animals are suffering from chemical testing and some of the tests employ	
2		acute toxicity testing of the eyes and skin resulting in irreparable damage,	
3.		irritation or injury; and	
4.	WHEREAS,	non-medical product testing on animals doesn't always correlate to humans; and	
5.	WHEREAS,	non-medical product testing on animals is an unnecessary form of abuse and causes	
6.		injury to animals who are simply returned to cages with no quality of life; and	
7.	WHEREAS,	only 40-60 % of the product testing actually works on humans; and	
8.	WHEREAS,	26 million animals are being caged in laboratories where chemicals are applied	
9.		to various parts of their bodies; now, therefore, be it	
10.	RESOLVED,	By the Congress here assembled that stop animal testing for commercial products	
11.		because it is dangerous, and sometimes inflicts pain or is lethal to the animals.
