

**A RESOLUTION TO FUND THE OFFSHORE WIND INDUSTRY
TO CREATE CLEAN ENERGY**

1 WHEREAS, The United States has a large offshore wind energy resource that is ready to be
2 utilized; and

3 WHEREAS, U.S. shores currently possess a power potential of over 2000 gigawatts or nearly
4 double the nation’s current electricity usage and will be able to generate
5 electricity for more than 115 million U.S. households; and

6 WHEREAS, Offshore Wind Energy has the potential to deliver large amounts of clean reliable
7 energy and reduce pollution oil spills; and

8 WHEREAS, Funding this industry will result in more than 200,000 jobs being created which is
9 about twice the number of jobs being created by other sources of energy such
10 as offshore drilling; and

11 WHEREAS, Offshore Wind Energy will also help create more jobs in the shipbuilding and
12 manufacturing industry further fueling the U.S. economy; and

13 WHEREAS, Wildlife and marine ecosystems are positively impacted by offshore wind farms
14 due to the fact that they act as effective marine reserves; and

15 WHEREAS, Wind farms can act as artificial reefs and protection from fishing pressures
16 creating extremely positive effects; now, therefore, be it

17 RESOLVED, That the Congress here assembled that the United States shall fund the Offshore
18 Wind Industry to create clean energy.

A RESOLUTION TO ESTABLISH REMEDIES FOR VICTIMS OF AMERICAN SLAVERY

1 WHEREAS, Approximately 4,000,000 slaves and their descendants contributed unpaid labor
2 to the U.S. economy from 1619 to 1865; and

3 WHEREAS, Multiple efforts have been made in the past to prevent the atrocity of systemic
4 racism from reproducing, all of which have failed; and

5 WHEREAS, Following the abolition of slavery, the United States government continued to
6 perpetuate, condone, and profit from practices that continued to brutalize
7 African Americans, including: sharecropping, convict leasing, Jim Crow laws,
8 redlining, unequal education, and disproportionate treatment at the hands of
9 the criminal justice system; and

10 WHEREAS, Because of these injustices, black unemployment is more than twice as high
11 white unemployment; black families are worth one-sixteenth of the wealth of
12 white families; and quality of life for black individuals and families has
13 continually worsened over time as a direct result of chattel slavery, Jim Crow,
14 the drug war, and other perpetuations of systemic racism; Now, therefore, be it

15 RESOLVED, By the Congress here assembled that a permanent committee be established to
16 develop an understanding of the government's role in slavery and systemic
17 racism and the long-term effects of each that continue today. This committee
18 shall also research and suggest appropriate remedies.

A BILL TO TAX MEGACHURCHES

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States Federal Government shall implement a 5% annual tax rate on
3 megachurches. The tax will be placed on the megachurch's annual
4 income.

5 SECTION 2. A megachurch is defined as any church with more than 1,000 members. Annual
6 income of a megachurch is defined as any kind of money brought into the
7 megachurch, including but not limited to donations, sales of DVDs, books, and
8 other merchandise, and money from televised services.

9 SECTION 3. The Internal Revenue Service shall oversee the implementation of this
10 legislation.

11 A. The Internal Revenue Service will reevaluate the size of churches and release
12 a report listing the churches that qualify as a megachurch every 5 years.

13 B. If the report finds that a new church qualifies as or is no longer qualified as a
14 megachurch, the change in taxation will take place at the beginning of the
15 next fiscal year.

16 SECTION 4. This bill will go into effect on January 1, 2022.

17 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO DEFUND AND REIMAGINE THE POLICE

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. States and localities shall pass laws designed to defund current police
3 departments.

4 SECTION 2. States and localities shall reorganize current police departments in order to
5 address police violence.

6 SECTION 3. States and localities that fail to pass laws to defund and reimagine current police
7 departments shall result in the loss of federal highway funds for their state or
8 locality.

9 SECTION 4. This bill will go into effect on June 1, 2021.

10 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO BAN ALL U.S. IMPORTS FROM CHINESE REGIONS THAT USE FORCED LABOR FROM CONCENTRATION CAMPS

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States federal government will halt all imports from regions in China
3 that utilize labor from its Xinjiang concentration camps to pressure the country
4 economically to end these camps.

5 SECTION 2. a. Imports are a good or service bought in one country produced in another.

6 b. Forced labor is any work or service that people are made to do against their
7 will under threat of punishment.

8 c. Concentration Camps are places where a large number of minorities are being
9 imprisoned in inadequate facilities to persecute them or force them into labor.

10 SECTION 3. The United States Customs and Border Protection will be responsible for the
11 oversight of this legislation by requiring all Chinese supply chains from regions in
12 China known to hold these concentration camps to be transparent on whether
13 or not they utilize labor from these camps.

14 SECTION 4. This bill will be implemented on January 1st, 2021

15 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO ENSURE GENETIC PRIVACY

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. Any organization (governmental or otherwise) must have specific consent
3 (renewed at the most every fifteen years) from the relevant living citizen for
4 such organization to hold any more than sixty percent of that individual's
5 consecutive genetic code for longer than sixty days.

6 SECTION 2. Genetic code will be defined as "the human genome, one that is specific to one
7 individual, living, human person." Organization will be defined as "any group or
8 individual capable of procuring or storing genetic information, including but not
9 limited to government groups, corporate groups, healthcare professionals, or
10 citizens."

11 SECTION 3. A nonprofit legal group will compile and locate violations, using \$18 million in
12 grants from the US department of Health and Human services via the
13 National Institute of Health. Then, based on the severity and repetition of
14 violations, punishments shall be determined by the Department of Health and
15 Human service's ethics council. These punishments may include:

16 a.) If the violating organization is a healthcare professional or group thereof,
17 revocation of federal medical licensure and/or a fine of up to \$10,000 per
18 offense.

19 b.) If the violating organization is a government group, loss of HHS or NIH
20 funding as well as an encouraged penalty via the state department of the
21 relevant state

22 c.) If the violating organization is a corporate group, revocation of business
23 licensure and/or a fine of up to \$12,000 per offense but will never result in jail
24 time.

25 SECTION 4. This legislation will be effective two years after its passage

26 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO INCREASE RESEARCH FUNDING TO THE NATIONAL CANCER INSTITUTE

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States Congress will increase research funding to the National Cancer
3 Institute by 50% of the current allocated budget of \$5 billion.

4 SECTION 2. The National Cancer Institute provides a number of benefits to public health

5 A. The NCI leads the nation's research efforts to improve cancer prevention,
6 detection, diagnosis, and survivorship

7 B. The NCI supports targeted cancer research training for individuals from
8 backgrounds underrepresented in the biomedical and behavioral sciences to
9 achieve and sustain a diverse workforce

10 SECTION 3. This legislation will be implemented by the United States National Institute of
11 Health and within that the National Cancer Institute.

12 A. The NCI shall operate in accordance with legislation guidelines; including
13 research, accounting and documentation.

14 B. Fiscal oversight will be maintained by the US Congress and the National
15 Institute of Health.

16 SECTION 4. This bill will be implemented on January 1st, 2021

17 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
