4	Whereas,	"no knock" warrants lead to confusion and panic typically causing
5		shooting by police and civilians resulting in police and civilian deaths; and
6	Whereas,	examples such as the deaths of Breona Taylor and Bounkham
7		Phonesavanh were directly related to "no knock" warrants; and
8	Whereas,	individuals responsible for these deaths were not held accountable because
9		of working under "no knock" warrants; now, therefore, be it
10	Resolved,	By the Congress here assembled that "no knock" warrants should be
11		banned in the United States.

14		embassies in Pyongyang; now, therefore, be it
15	Resolved,	By the Congress here assembled that the UnitedStates formally
16		petition the Ministry of Foreign Affairs of the People's Democratic
17		Republic of Korea for permission to open an embassy of the United
18		States in Pyongyang

A Resolution to Grant Statehood to Puerto Rico

1	Whereas,	The United States currently holds federal power over the island
2		territory of Puerto Rico; and
3	Whereas,	The United States currently has the ability to significantly improve the
4		quality-of-life and economic status of Puerto Rico by providing the
5		same benefits that current states hold; and
6	Whereas,	Both the US and Puerto Rico will benefit economically through
7		statehood. Puerto Rico can contribute nearly \$2 billion to the US
8		Treasury every year and bring in a large amount of extra revenue
9		through taxes; and
10	Whereas,	Puerto Rico would have access to more financial aid from the US
11		government; and
12	Whereas,	Puerto Rico would be able to enter into an open trade market with the
13		United States and its allies; and
14	Whereas,	Statehood would provide Puerto Rico with representation in the
15		government and the right to vote in elections; and
16	Whereas,	Puerto Ricans would be granted full United States citizenship; now,
17		therefore, be it
18	Resolved,	By the Congress here assembled that that the United States will grant
19		Puerto Rico statehood.
