Introducing a brand-new initiative called: **North East Alliance Tournament**. This tournament's mission is to provide a pilot program in organizing and running forensic tournaments within the Northeastern United States.

It is no secret that forensics has faced a long decline within the Northeast. As of late, many programs are threatened with budget cuts, abrupt coaching staff changes and eliminations, and diminished financial support from their institutions. Many endangered programs face an uncertain future during unsettling times.

From Maine to New York and beyond, student-run and small teams are the lifeblood of our regional forensics community. Therefore, NEAT tournaments are a way to strengthen alliances and to form new ones. Our goal is threefold:

- 1. Strengthen and collaborate with existing forensic teams within the Northeast.
- 2. Assist threatened forensic programs by providing financial and logistical consultation.
- 3. Outreach by establishing new forensic programs in neighboring colleges and universities.

By encouraging more forensic participation within the Northeast, we hope that our efforts will help strengthen existing programs and create opportunities for small and new teams to flourish within our region in a variety of exciting competitions. We hope to provide teams tournament hosting opportunities throughout the annual competition season.

Our tournaments will offer the following events:

- Individual Speech Events, Open (I.E.) (offered at all tournaments)
- National Parliamentary Debate, Open (NPDA) (offered at all tournaments)
- International Public Debate, Novice/Open (IPDA) (offered at all tournaments)
- Worlds / British Parliamentary Debate (offered only if there is enough entries)
- Public Forum, Open (PF) (offered only if there is enough entries)
- Lincoln-Douglas Debate, open (NFA-LD) (offered only if there is enough entries)
- Policy Debate, open (NDT-CEDA) (offered only if there is enough entries)



- NDT-CEDA will only feature THREE preliminary rounds followed by only ONE elimination round.
- Students MAY NOT cross-enter in both debate and I.E.'s (Individual Events)!

- NDT-CEDA Policy Round 1 is at 9:00AM; Round 2 is at 12:15PM; Round 3 is at 1:45PM; and CEDA Finals is at 3:30PM

I.E. & DEBATE ENTRY RULES

- All entries are due on the Monday afternoon at 5pm EST prior to the tournament via Speechwire.
- All students must be undergraduates enrolled at their respective institution.
- All teams are expected to provide an adequate number of judges to accommodate their entries.
- The tournament director reserves the right to reject excessive entries that are not properly covered by judges.
- It is up to your discretion to place and enter students in their proper division in IPDA debate (i.e. novice or varsity).
- Absolutely no individual can debate without a partner in NPDA, British Parliamentary, Public Forum and in Policy Debate!
- Absolutely no individual can cross-enter in both I.E.'s and debate!
- Any school may enter an unlimited number of students per event provided they supply sufficient judges that covers their entry.
- Each student may be entered up to 3 events per I.E. speech pattern.
- Each student must be eligible to compete under their respective sanctioning organization's rules and guidelines for their event.
- Coaches are highly encouraged to enter their student's pronouns and pronunciation on their Speechwire entry.

SCHOOL SWEEPSTAKES AWARDS

- 1. Awards will be presented to each finalist within their respective event.
- 2. In each debate format except NDT-CEDA, there will be three elimination rounds (depending on number of entries): Quarterfinals, Semifinals, and Finals.
- 3. Team sweepstakes points are awarded as follows:

POINTS FOR INDIVIDUAL EVENTS:

- a. 2 points for each $6^{th} 7^{th}$ Place Finalist
- b. 4 points for each 4th 5th Place Finalist
- c. 6 points for each 3rd Place Finalist
- d. 8 points for each 2nd Place Finalist
- e. 10 points for each 1st Place Finalist

POINTS FOR IPDA & NPDA DEBATE:

- a. 3 points for each preliminary win (regardless of how many teams per division; teams earning less than 2 wins receive no sweepstakes points)
- b. 3 additional points for reaching Quarterfinal Rounds
- c. 3 additional points for reaching Semifinal Rounds
- d. 3 additional points for reaching Final Round

POINTS FOR NFA-LD, PUBLIC FORUM & NDT-CEDA DEBATE:

- a. 3 points for each preliminary win
- b. 4 additional points for reaching Quarterfinal Rounds
- c. 4 additional points for reaching Semifinal Rounds
- d. 8 additional points for reaching Final Round

POINTS FOR BRITISH PARLIAMENTARY DEBATE:

- a. 2 points for every team preliminary ranking of 1st place
- b. 1 point for every team preliminary ranking of 2nd place
- c. 0 points for every team preliminary ranking of 3rd and 4th place
- d. 4 additional points for each team advancing to each elimination round.
- 4. In addition, the top individual speakers and top debate schools across the six debate formats will be recognized.

TOURNAMENT AWARDS

Due to the economic and environmental costs associated with shipping awards, online certificates will be awarded in place of most trophies. However, we will give physical sweepstakes awards to the top 3 schools in each event and for the top speaker in each debate format.

TOURNAMENT FEES

We genuinely want to provide all programs the chance to participate.

Please contact us if you want to attend the tournament but are concerned about the fees, we are aware some programs have been severely affected by budget cuts and will try to make allowances for those programs.

IF YOU ARE MAKING A PAYMENT EITHER BY CREDIT/DEBIT CARD OR BY CHECK, YOU CAN SEND US PAYMENT VIA YOUR PAYPAL INVOICE. DETAILS WILL BE PROVIDED IN THE COMING DAYS NEAR TOURNAMENT DAY.

- 2. Fees for uncovered debaters will be assessed as follows:
 - Every uncovered speaker = \$10 per I.E. speech slot
 - Every uncovered debater = \$40 per IPDA & LD debater
 - Every uncovered team = \$80 per NPDA / BP / PF / NDT-CEDA team
- 3. Fees will initially be calculated on the Monday afternoon prior to each tournament at 5PM EST. Late adds/drops will be as follows:
 - Add/drops on the Tuesday & Wednesday prior to the tournament: \$20 per change, plus entry fee
 - NO MORE ADDS ALLOWED ON THURSDAY!!!!
 - Drops on the Thursday prior to the tournament: \$70 per drop, plus entry fee
 - Drops at tournament registration:
 \$100 per drop, plus original entry fee
 - ABSOLUTELY NO ADDS ALLOWED ON FRIDAY AND SATURDAY!!!
- 4. Each judge covers:
 - 5 IE slots
 - 2 IPDA / NFA-LD entries.
 - 1 NPDA / BP / PF / NDT-CEDA team
 - Therefore, schools with excess entries will be charged "uncovered slots" for every debater that is not covered by a judge. So please make every effort to cover your entry. Schools are responsible for entering their judges as the right judge type when calculating fees.

- 5. A special note about BP / PF / NPDA & CEDA judges:
 - BP / PF / NPDA and CEDA judges are handled differently than other debate formats.
 - Therefore, each BP / PF / NPDA and CEDA entry MUST provide at least one judge PER entry.
 - All BP / PF / NPDA and CEDA judges are expected for judging all rounds, including elimination round(s).
 - BP / PF / NPDA and CEDA judges may not judge other debate formats in our tournament due to time conflicts.
 - British Parliamentary Debate traditions allows non-competing undergraduate students to judge that still have eligibility.
- 6. Judges who fail to pick their ballots will render their students ineligible for elimination rounds.
- 7. Lastly, student-run and small teams are the life blood of our forensics community. We recognize that so many teams are threatened with budget cuts, coaching staff turnover, and diminished resources from their institutions. If this is your first debate tournament and do not have the means to cover your entire entry fee, please reach out to us and we will be happy to accommodate you. We want you to attend our tournament and have a great debate experience! We only ask that you bring enough judges to adequately cover your entry.

IMPORTANT TOURNAMENT INFO

WARM ROOMS

Our tournament will not have "warm rooms." While we encourage cordial and constructive feedback between judges and debaters, judges should not be obliged to engage in conversation with students. Debaters should not pressure their judges for commentary after rounds. JUDGES SHOULD NOT DISCLOSE THEIR REASON FOR DECISIONS (RFD) DURING OR AFTER ROUNDS!

JUDGING

All schools should attempt to properly cover their entries. If you have a judge who doesn't feel comfortable judging debate rounds, please note it when you place your entry so that we can accommodate you. We are fortunate to be placed in a region of many highly qualified judges, educators, and former debaters!

DEBATE ROUND FORFEIT RULE

Any debater who is more than <u>15 minutes late</u> to their assigned virtual room automatically forfeits their round, resulting in a "bye" or automatic win for the opposing debater. Please make every effort to have your debaters appear at their appointed rounds so that our tournament runs smoothly.

ETHICS STANDARDS OF INDIVIDUAL EVENTS AND ALL DEBATE FORMATS

The North East Alliance Tournament will adhere to the rules prescribed by the International Public Debate Association (for IPDA debate), the National Parliamentary Debate Association (for NPDA debate), the National Forensic Association (for NFA-LD), the American Forensic Association (for I.E. speech events), the National Debate Tournament (for Policy debate), the College Public Forum League (for PF debate) and the World Universities Debating Council (for BP debate). Before tournament day, please take time to familiarize yourself and your team to the rules contained within the Constitution and its Bylaws of these organizations.

DEBATE PAIRINGS

All preliminary rounds across all debate formats will be randomly paired. However, brackets will not be broken in elimination rounds.

INDIVIDUAL EVENTS COMPETITION RULES

It is my wish for everyone to have an enjoyable experience at the tournament. To ensure fairness, the following rules will be observed:

INDIVIDUAL SPEECH EVENTS

The American Forensic Association National Speech Tournament (AFA-NST) rules and descriptions will govern all Individual Speech Events.

Individual Speech events are as follows:

- A. Students may not have competed with the selections in any intercollegiate competition prior to September 1, 2022.
- B. As per the AFA-NST language, the use of the Internet and/or electronic files are permitted in Extemp.
- C. The following events will be offered in open divisions of competition:
 - PATTERN A: Impromptu, Dramatic Interpretation, ADS, CA, Prose
 - PATTERN B: Extemp, Persuasive, POI, Duo, Poetry, Informative
- D. Oral interpretation and Public Address individual speeches must follow the 8-10-minute format. Limited Preparation speeches are limited to only 7 minutes of speaking time.
- E. Competitors are expected to cite their sources orally in Public Address and Extemporaneous speech events.

IPDA DEBATE COMPETITION RULES

INTERNATIONAL PUBLIC DEBATE ASSOCIATION (IPDA)

It is my wish for everyone to have an enjoyable experience at the tournament. To ensure fairness, our tournament will follow IPDA rules found within the IPDA Constitution and Bylaws which were last updated on October 2018. To view the constitution, please visit the website at: http://www.ipdadebate.info/constitution-bylaws.html.

According to the IPDA Constitution, "IPDA" or the "International Public Debate Association" is an audience-friendly debate format with great emphasis on persuasion, rhetorical speaking abilities, and inclusivity of interested individuals who are encouraged to debate "regardless of educational background, prior experience, or any other demographics." The philosophic tenets of the IPDA Constitution are sevenfold, which are inclusivity, lay judging, limited preparation, extemporaneous delivery, rhetorical delivery, and ethos.

It is important to note that IPDA Debate differs from other collegiate debate formats since it encourages lay judging – judges with limited debate experience and training to ensure fairness within debate rounds. Therefore, handouts of the IPDA debate format will be distributed at check-in to all lay judges who request a copy of the IPDA Debate rules.

The IPDA Debate format are as follows:

- A. Topics will be announced in-round with 5 topics (2 value, 2 policy, 1 metaphor) provided for strikes. Negative strikes first, and then turns are taken until one topic remains to be debated.
- B. <u>Debaters will not be allowed to consult any other person during prep time, including coaches.</u> Per IPDA rules, they will be allowed paper and/or electronic research material, which may be quoted or paraphrased from notes during the round, but not read directly, as extemporaneous delivery is required.

C. Time limits:

Affirmative Constructive 5 minutes
Cross Examination 2 minutes
Negative Constructive 6 minutes
Cross Examination 2 minutes
First Affirmative Rebuttal 3 minutes
First Negative Rebuttal 5 minutes
Second Affirmative Rebuttal 3 minutes

ADDITIONAL NOTES ON THE IPDA DEBATE FORMAT

- Competitors will receive their topics at their designated competition room 30 MINUTES BEFORE THE ACTUAL ROUND BEGINS. (Example: if the first round starts at 9:00AM, then competitors MUST be at their designated rooms no later than 8:30AM).
- Judges are expected to keep time during rounds. IPDA competitors will have exactly 30 minutes of preparation time following the first negative strike.
- IPDA strike sheets will contain a variety of topics ranging from domestic, economic, social and international events.

NPDA DEBATE COMPETITION RULES

NATIONAL PARLIAMENTARY DEBATE ASSOCIATION (NPDA)

NPDA is the National Parliamentary Debate Association. Our tournament will follow the NPDA rules last updated in March 2008. NPDA Debate rules can be accessed here:

The NPDA Debate format are as follows:

- A. Topics will be announced in-round. A different resolution for each round will be presented to the debaters at a specified time prior to the beginning of each debate.
- B. Debaters will not be allowed to consult any other person during prep time, including coaches. Per NPDA rules, they will be allowed paper and/or electronic research material during their prep time, which may be paraphrased from notes during the round, but not read directly, as extemporaneous delivery is required.
- C. The topic of each round will be about current affairs or philosophy. The resolutions will be general enough that a well-educated college student can debate them. They may be phrased in literal or metaphorical language.

NFA-LD DEBATE COMPETITION RULES

LINCOLN – DOUGLAS DEBATE (NFA-LD)

"NFA - LD" is Lincoln-Douglas Debate of the National Forensic Association. We will use the most recent rules and bylaws within the NFA Constitution.

The NFA-LD Debate format are as follows:

- 1. For an open division of NFA-LD Lincoln Douglas Debate, the rules are:
 - a. The 2022 2023 resolution shall be used.
 - b. All preliminary rounds will be randomly preset. Brackets will NOT be broken in elimination rounds.
 - c. Time limits: 6-3-7-3-6-6-3 with 4 minutes of flexible prep time.
 - d. All participants in NFA-LD are advised to visit the NFA website and familiarize themselves with the NFA-LD by-laws.
- 2. NO disclosure in debate rounds. Please turn in ballots before offering any oral critiques.

BP DEBATE COMPETITION RULES

BRITISH PARLIAMENTARY DEBATE (BP / WORLDS)

"BP" stands for British Parliamentary Debate and is the most widely adopted debate format across the world. Our tournament will be following the BP rule guidelines ascribed by the World Universities Debating Council. You may access the rules here:

The BP Debate format are as follows:

- A. Topics will be announced in-round. A different resolution for each round will be presented to the debaters at a specified time prior to the beginning of each debate.
- B. Debaters are encouraged to consult their debate partners during motions. Per BP rules, they will be allowed paper and/or electronic research material during their prep time, which may be paraphrased from notes during the round, but not read directly, as extemporaneous delivery is required.
- C. The topic of each round will be about current affairs or philosophy. The resolutions will be general enough that a well-educated college student can debate them. They may be phrased in literal or metaphorical language.

COLLEGE PUBLIC FORUM DEBATE (PF)

The PF Debate format are as follows:

- A. PF topics will be announced on the CPFL website.
- B. PF teams are comprised of two debaters from each side.
- C. PF teams will be paired randomly.
- D. Each team is allotted a total of three minutes of preparation, which can be used before any speech in the debate.

POLICY DEBATE COMPETITION RULES

POLICY DEBATE (NDT-CEDA)

"NDT-CEDA" stands for Policy Debate. We will use the most recent rules and bylaws within the National Debate Tournament (NDT) revised in January 2022. You may access the rules here: https://nationaldebatetournament.org/wp-content/uploads/2022/04/Standing-Rules-Revised-Jan2022-1.docx.

The NDT-CEDA Policy Debate format are as follows:

- A. Policy topics are announced annually at CEDA. The 2022 2023 resolution will be used.
- B. Policy teams are comprised of two debaters from each side.
- C. Policy teams will be paired randomly. The tournament director will announce the first and third preliminary round orally.
- D. All students must be eligible to compete in compliance with the American Forensic Association (AFA) Debate Program and Debate Tournament Standards.
- E. Preparation Time Each team is allotted a cumulative total of ten minutes of preparation. This time includes: amount of time elapsed between the announced time for starting the round and when the team is ready to debate, organizational time, and any other time for preparation. Upon exhaustion of the allotted preparation time, any additional preparation time shall be deducted from subsequent speeches.
- F. Tech Time If debates occur utilizing an online platform, each team shall be allotted up to fifteen total minutes of "Tech Time". This time is exclusively for resolving uniquely online tech-related problems (e.g. internet connection, audio/video issues). Tech time should not be used as additional standard prep time. If the time elapses before the team can resolve the issue within the official tournament platform, they will forfeit the debate. In the event a speech needs to be redelivered entirely or in part, the time for that should count as tech time for the team experiencing the problem, if their tech time runs out while giving the speech, the remaining time should be deducted from prep time.
