Judging Rules

- 1. All schools must provide at least one qualified judge for every round of events. For every 20 entries, they must provide an additional judge.
- 2. Judges **must** remain in their room until all performances have been viewed unless otherwise noted.
- 3. Judges can be coaches, members of the community, former students, and <u>for NOVICE rounds of debate only, current Varsity members with more than 150 NSDA points</u>.

Overall Winners

All debate breaks will be awarded during the awards ceremony. Speech finalists will also be similarly awarded during the tournament.

Sweepstakes Points

Sweepstakes plaques will be awarded to the top three schools only,

Sweepstakes will be awarded to the top three schools in debate, speech, and overall tournament. We will consider novice and varsity entries when awarding sweepstakes awards. Sweepstakes will be determined using the following criteria:

Points in Events & Debate will be awarded to the top four entries from each school as follows:

Event Semi-Finals	five points
Event Finals	ten points
Event Third Place	five points
Event Second Place	ten points
Event First Place	fifteen points
Debate Win	. two points
Debate Semifinals	. ten points
Debate Finals	fifteen points

General Rules and Suggestions

- 1. A student may be triple entered. However, they may only be entered in one debate and one draw.
- 2. Debates (Policy, Lincoln-Douglas, Public Forum) will be power-matched for round three and four.
- 3. All MSHSAA rules will be used where applicable. For NSDA-only events, standard NSDA rules will apply.
- 4. Internet use is permitted. All MSHSAA guidelines will be followed.
- 5. In the event of a major snowstorm or other conditions which prevent travel, we will move to a virtual format. Schools will have the option to opt out if desired (Opt out-fees will be refunded).

Event Specific Rules

These are the expectations for speech and debate events with special requirements. All other events will follow the rules listed above.

Debate:

- 1. Standard MSHSAA rules will apply to all debates.
 - Policy: 8 minutes of prep per side
 - LD: 4 minutes of prep per side
 - PF: 3 minutes of prep per side
- 2. Competitors should report to rooms 15 minutes in advance of their rounds.
- 3. Once again, debates will be power-matched after round 2.
- 4. No maverick teams will be allowed.

Congress:

1. Standard NSDA Congressional Debate rules and Parliamentary Procedures will apply to all rounds. Eastern Missouri District Docket will be used for the selection of legislation

- i. Neither authorship nor sponsorship will be preferred over regular affirmative speeches.
- ii. Selection shall be based on the standard Eastern Missouri system. Votes shall be for setting individual bills on the docket and not for a full docket at once.
- 2. PO's for both rounds of competition will be selected at the beginning of the first session and elections will be facilitated by a member of tabulation staff for the tournament.
- 3. The top competitors, after preliminary rounds, will qualify for the final supersession of congress where all standard procedures will be followed.
 - a. At the beginning of the supersession round the Permanent Presiding officer will be selected and will be awarded with a gavel.
