2                    Their influence within not only Mexico but United States; and  
3   **WHEREAS,**   The United States will assist in these operations if approved by the  
4                    Mexican government by conducting joint military actions; and  
5   **WHEREAS,**   Mexican TCO's have caused innumerable amounts of death and  
6                    destruction throughout the Americas and have majorly contributed to  
7                    mass forced migration throughout the Americas; and  
8   **WHEREAS,**   The scope and command of these operations are to the discretion of the  
9                    Mexican government, however US involvement must be approved by the  
10                  Joint Chiefs of Staff; now, therefore, be it  
11   **RESOLVED,**   By the Congress here assembled that the United States military will assist  
12                  the Mexican government with Anti-Cartel operations.

## A Resolution to Expand Educational Equality (EEE)

1           **WHEREAS,**     millions of students attend American colleges and  
2           universities each year; and  
3           **WHEREAS,**     the cost of higher education is rising at an unprecedented  
4           rate; and  
5           **WHEREAS,**     students of all income levels can no longer rely on private  
6           colleges and universities to provide them with affordable education  
7           opportunities; and  
8           **WHEREAS,**     the cost of attendance for many colleges and universities,  
9           both public and private, can be extremely difficult to calculate, leading to  
10          poor financial decisions; and  
11          **WHEREAS,**     automatic merit-based scholarships for public colleges and  
12          universities have been implemented in certain states, using a number of  
13          objective educational standards, including but not limited to: GPA,  
14          SAT/ACT scores, and community service hours; and  
15          **WHEREAS,**     such programs have led to an increase in positive financial  
16          and educational outcomes for minority and low-income students; now,  
17          therefore be it  
18          **RESOLVED,**     That the Congress here assembled work with the  
19          Department of Education and state governments to establish and fund  
        automatic merit-based scholarships for public colleges and universities  
        using state-chosen standards.  
  
        **FURTHER RESOLVED,** That such increase in automatic merit-based  
        scholarship funding shall not reduce spending on need-based financial aid  
        programs for public colleges and universities.

# A Bill to Invest in Nuclear Fission

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1           **SECTION 1.**   This bill will provide the necessary support necessary for the  
2           commercial deployment of advanced nuclear fission reactors, and power  
3           plants as a clean energy source. A Nuclear Industrial Base and Sustainment  
4           Program shall be implemented to aid the persons or organizations within  
5           the federal government and the private sector that are engaged in  
6           designing, maintaining, or developing nuclear energy systems.

7           **SECTION 2.**   “Nuclear power” shall be defined as electricity generated by  
8           power plants that derive their heat from fission in a nuclear reactor.  
9           “Renewable energy” shall be defined as clean energy that comes from  
10          natural sources or processes that are constantly replenished.

11          **SECTION 3.**   The U.S. Department of Energy will oversee the  
12          implementation of this bill, and establish a program that provides financial  
13          assistance for the commercial planning, licensing, development, and  
14          construction of advanced nuclear fission reactors.

15          **SECTION 4.**   This legislation will take effect immediately upon passage.  
16          All laws in conflict with this legislation are hereby declared null and void.

**Bill to Legalize Performance Enhancing Drug Use to  
Level the Playing Field in Professional Sports**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** Rather than having an unknown number of athletes successfully hiding PED use, dominating  
3 over athletes who cannot afford the same measures. This bill seeks to legalize use of PEDs  
4 and other competitive measures to make professional sports more competitive. The  
5 allowances of this bill would be restricted to adults.

6 **SECTION 2.** Professional Sports is defined as domestic sports or competitive events in which athletes  
7 receive salaried compensation by their team or league for their performance in the form of  
8 money.

9 **A.** Domestic sports are defined as any sport that takes place on United States soil.

10 **B.** Performance Enhancing Drugs or “PEDs” - including but not limited to: anabolic  
11 steroids, Human Growth Hormone (HGH), or any other banned drug or  
12 measure outlined by the World Anti-Doping Agency’s banned substances and  
13 methods list.

14 **SECTION 3.** The United States Anti-Doping Agency (USADA) will enforce the safe practice of PED use.

15 **A.** Teams and athletes will be required to:

16 **a.** Have PED regimens decided upon under monitoring and consulting of a  
17 licensed medical professional

18 **b.** disclose and chronicle use of methods and substances taken, in a bi-weekly  
19 report submitted to USADA.

20 **B.** A bi-partisan committee including both medical professionals and experts in individual  
21 state athletic commissions will draft a list of safety standards.

22 **SECTION 4.** Will begin for all leagues at the start of their 2025 seasons.

23 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

# **A Bill to Fund the CISA to Prepare the US for Cyberwarfare**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1    **SECTION 1.**    \$15,000,000,000 of the annual Department of Homeland Security (DHS)
- 2                      budget will be transferred from the DHS to the Cybersecurity and
- 3                      Infrastructure Security Agency (CISA).
- 4    **SECTION 2.**    An annual budget shall be defined as the amount of money allocated to
- 5                      an organization in a fiscal year.
- 6    **SECTION 3.**    The CIA will be responsible for overseeing the allocation of funds.
- 7    **SECTION 4.**    This legislation will take effect on December 31, 2022.
- 8    **SECTION 5.**    All laws in conflict with this legislation are hereby declared null and void.

## **A Resolution for NATO to substantially increase defense commitments to the Baltic States**

1           **WHEREAS,** NATO has a duty to protect all of its member countries and  
2           their citizens.

3           **WHEREAS,** Defense commitments shall be defined as weapons, soldiers,  
4           technology, and NATO Intelligence.

5           **WHEREAS,** Russia has become a more prominent threat to countries in  
6           the European region. The defense commitments help protect the Baltic  
7           states against any arising threats.

8           **WHEREAS,** The funding for this bill shall be 1 billion dollars in the form  
9           of soldiers, weapons, and medical assistance.

10          A. The funding will come from the entirety of NATO countries.

11           **RESOLVED,**

12          A. The execution of this bill will be overseen and managed by NATO

13          B. This legislation will take effect on January 1, 2023.

14          C. All laws in conflict with this legislation are hereby declared null and void.
