

CHSAA 5A State Tournament Final Session Bill 1

A Bill to Repeal the Merchant Marine Act of 1920

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** The Merchant Marine Act of 1920, requiring that any cargo
3. traveling by sea between two U.S. ports must sail on an
4. American-owned ship, is hereby repealed
5. **SECTION 2.** The following definitions apply:
6. **A.** American-owned shall be defined as being owned and operated
7. by American businesses.
8. **SECTION 3.** The Department of Commerce shall take necessary steps to
9. ensure stability and popular support upon the passage of this
10. bill.
11. **SECTION 4.** This bill shall be implemented immediately upon passage.
12. **SECTION 5.** All laws in conflict with this legislation are hereby declared null
13. and void.

The PREGO Act **(The “Preparing for Responsible Experience with** **Gestational Outcomes” Act)**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 **SECTION 1.** The PREGO Act aims to educate students on the prevention and
2 management of underage pregnancies through providing comprehensive
3 sexual education for adolescent and young adults in US public high schools.
- 4 **SECTION 2.** To be able to graduate high school, students are required to take a
5 semester of a sexual education class with a PREGO-approved curriculum. In
6 addition, schools will be required to provide contraceptive products, such
7 as condoms, to aid in the prevention of teenage pregnancies.
- 8 **SECTION 3.** The US Department of Education will oversee implementation of this bill.
- 9 A. \$50 million will be allocated for initial implementation of this policy,
10 and future funding will be allocated annually through the regular
11 budget process after the initial funding is depleted.
- 12 B. Failure of a public school or public school district to apply a
13 PREGO-approved sexual education curriculum will result in a loss of
14 accreditation, resulting in invalid high school diplomas or
15 high school diploma equivalents effective until the curriculum is
16 adopted and accreditation is restored.
- 17 **SECTION 4.** This legislation will take effect prior to the start of the 2024-2025 school
18 year. All laws in conflict with this legislation are hereby declared null and
19 void.

A Resolution to Stop Selling Arms to Saudi Arabia

Whereas, The US has sent over 3 billion dollars in weapons to the kingdom of Saudi Arabia; and

Whereas, Saudi Arabia has used these weapons in a proxy war against Iran in Yemen; and

Whereas, Most recent reports indicate Saudi Arabia's US-supplied air campaign has killed over 24,000 people, including over 15,000 non-combatants; and

Whereas, The Saudi government has also been accused of active funding and stocking Al-Qaeda cells within their borders; and

Whereas, Saudi Arabia also utilizes this weaponry to openly suppress the human rights of minorities and women within their country; and

Whereas, Saudi Arabia continues to fund other terror groups within the Middle East to destabilize the region; now, therefore, be it

Resolved, The Congress here assembled that the US stop all arms sales and military training to the Kingdom of Saudi Arabia.

CHSAA 5A State Tournament Final Session Bill 4

A Bill to Implement Tax Benefits For Those Who Take the Covid-19 Vaccine

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The United States Government through the Internal Revenue Service will
2 give tax benefits amounting to five-hundred U.S. dollars for any United
3 States Citizens who take the Covid-19 Vaccine.

4 **SECTION 2.** Taking the Covid Vaccine will be defined as having a Covid 19 Immunization
5 Record.

6 **SECTION 3.** The Internal Revenue Agency (IRS) will implement and oversee an
7 application system. One billion dollars will be allocated towards the
8 creation of the system.

10 **SECTION 4.** This legislation will take effect on January 1, 2023. All laws in conflict with
11 this legislation are hereby declared null and void.

A Resolution to Target Syrian Earthquake Relief

1 **WHEREAS,** A major earthquake hit northern Syria in early February and has resulted in
2 major damage to the entire region; and

3 **WHEREAS,** Thousands of lives have been lost and even more people injured along with
4 a vast majority of infrastructure being destroyed, but extremely limited aid
5 is being provided by the Syrian government; and

6 **WHEREAS,** The current government headed by President Bashar al-Assad is inherently
7 corrupt and has failed to provide its people with the necessary aid and
8 resources to allow for people to recover and for the rebuilding process to
9 begin; and

10 **WHEREAS,** The people of the region are desperately in need of any and all aid because
11 of the devastating conditions that they are living in; now, therefore, be it

12 **RESOLVED,** That all aid for Syria from the United States of America shall be provided
13 only to democratic opposition groups to the Assad government; and, be it

14 **FURTHER RESOLVED,** That the United States of America encourages other nations to
15 provide aid to similar groups in Syria for the purpose of earthquake relief.

The Second Homesteading Act

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** Select amounts of Federal land shall be handed over to
3. States for free, so long as the land has minimal zoning
4. regulations, and low taxes for developers
5. **SECTION 2.** The following definitions apply:
6. **A.** The select amount shall be determined by negotiations between
7. individual states and the Federal government.
8. **B.** "Low Taxes" shall be defined as a 10% or lower tax rate on the
9. creation of new improvements.
10. **SECTION 3.** The Department of the Interior and it's Bureau of Land
11. Management shall oversee negotiations.
12. **SECTION 4.** This program will go into effect January 1st of 2026.
13. **SECTION 5.** All laws in conflict with this legislation are hereby declared null
14. and void.
