

The American Bottle Bill of 2024

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** All sellers of plastic bottles, such as convenience or grocery stores,
3 shall receive a cut in corporate income tax (CIT) for instituting
4 a container-deposit system.

5 A. Sellers who offer \$0.05 compensation per bottle shall have their
6 corporate income tax reduced by 1.25%.

7 B. Sellers who offer \$0.10 compensation per bottle shall have their
8 corporate income tax reduced by 2%.

9 **SECTION 2.** Plastic bottles shall be defined as bottles constructed from
10 high-density or low density plastic, typically used to store liquids
11 such as water.

12 A container-deposit system shall be defined as a system where
13 consumers may deposit used plastic bottles at the same store in
14 which were purchased for a small monetary compensation.

15 The store may dispense compensation in the form of currency or
16 store credit.

17 **SECTION 3.** This legislation shall be overseen by the U.S. Environmental
18 Agency (EPA) and the United States Department of Commerce.

19 **SECTION 4.** This legislation will take effect immediately upon passage.

20 All laws in conflict with this legislation are hereby declared null
21 and void.

A Bill to End the Malicious Use of Artificial Intelligence

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The use of artificial intelligence to mimic the voice of an
3 individual shall be forbidden unless written consent is given by an
4 individual or their estate.

5 a. Artificial intelligence shall not be used to mimic the voice of an
6 individual who is a legal minor.

7 b. The use of artificial intelligence to defame the character of an
8 individual shall carry the same penalty as defamation would in
9 any other instance.

10 **SECTION 2.** Artificial intelligence shall be defined as a machine-based system
11 that uses machine and human-based inputs to produce outputs in
12 human-defined parameters that include text, images, and audio.
13 Mimicking, for the purposes of this legislation, shall be defined as
14 copying or imitating speech in a manner that bears little to no
15 difference to actual speech.

16 **SECTION 3.** This bill shall take effect on July 1, 2024.

17 **SECTION 4.** The Federal Trade Commission shall be responsible for enforcing
18 this legislation. All other laws in conflict with this new policy shall
19 be null and void.

A Bill to Abolish the Refugee Admissions Cap

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** There will no longer be a cap on how many refugees the United
3 States Citizenship and Immigration Services (USCIS) may admit.
4 The refugee admissions cap will no longer be used to determine
5 how many refugees may enter the country.

6 **SECTION 2.** The refugee admissions cap is defined as the limit placed on how
7 many people may be granted asylum as refugees in the United
8 States, determined by the executive branch.

9 **SECTION 3.** The United States Citizenship and Immigration Services (USCIS)
10 will oversee this legislation.

11 **SECTION 4.** This legislation will take effect on January 1, 2025. All laws in
12 conflict with this legislation are hereby declared null and void.

**A Bill to Create the Transpacific Security Organization to
Counter Chinese Expansionism**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 **SECTION 1.** The United States will create the Transpacific Security
3 Organization (TSO) to formally counteract Chinese expansionism
4 and intimidation in Asia. The TSO will follow a collective defense
5 principle.

6 **SECTION 2.** A. The TSO will follow a collective defense principle where any
7 acts of war from a non-member state onto a member will result in a
8 joint defensive response to defend the ally nation and ensure its
9 self-determination.

10 B. The founding members of the organization will consist of:
11 Japan, Australia, Taiwan, South Korea, the Philippines, and
12 the United States of America.

13 C. In the case of Chinese expansionism in the South China Sea or
14 intimidation of member states, the TSO will convene to decide on
15 decide on the official course of action by all members.

16 D. Joint defensive response will be defined as any economic and
17 military measures to protect the full territorial integrity of a nation,
18 including, but not limited to deployment of military force.

19 **SECTION 3.** The United States Department of Defense (DOD) will oversee
20 enforcement along with the specific enforcement mechanism.

21 **SECTION 4.** This legislation will take effect immediately upon passage.

22 All laws in conflict with this legislation are hereby declared null
23 and void.
