

April 2024 FFL Novice/Middle Final Round Legislation

A Bill to Alter Criteria for Firearm Licenses

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 Section 1. A psychiatric professional must certify all applicants for a concealed
3 weapon, before the state office approves him/her based on the other state
4 criteria for the resident's state. The psychiatrist will have to file a form to
5 the application certifying enough mental stability to handle a lethal
6 weapon.

7 A. If a person is declared unstable and therefore unable to obtain a
8 weapon, they will be prohibited from reapplying or obtaining
9 another psychiatric evaluation for a period of two years.

10 Section 2. A. The term "lethal weapon" as used above refers to any weapon that
11 requires a license, as dictated by the state of the applicant, or any
12 weapon that fires a projectile that can inflict lethal wounds unto a
13 person.

14 B. The term "form" as used above refers to a document signed by a
15 registered psychiatrist to be submitted along with the application of
16 the license.

17 Section 3. The Bureau of Alcohol, Tobacco and Firearms will be responsible for
18 overseeing implementation of this legislation.

19 Section 4. This legislation will take effect January 1, 2025.

20 Section 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Increase Funding to the Israeli Military

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 Section 1. Two billion dollars of shall be given to the Israeli military to improve and
3 upgrade their Iron Dome defense system.

4 Section 2. Upgrades will include, but are not limited to, construction of new
5 batteries, the replacement of outdated materials, and investment in new
6 technology research.

7 Section 3. The Department of Defense will be responsible for the implementation of
8 this legislation

9 Section 4. This legislation will take effect January 1, 2025.

10 Section 5. All laws in conflict with this legislation are hereby declared null and void.

April 2024 FFL Novice/Middle Final Round Legislation

A Bill to Initiate Direct Price Control on Prescription Drugs in the United States

1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

2 Section 1. The price of prescription drugs will be set through negotiation with the
3 manufacturer after the drug is approved by the Food and Drug
4 Administration.

5 Section 2. “Direct Price Control” shall be defined as “government restrictions on
6 prices that can be charged for goods and services in a market after
7 being negotiated with the manufacturers.”

8 Section 3. The Food and Drug Administration will oversee enforcement of this bill.
9 The Food & Drug Administration will also set the prices of prescription
10 drugs after negotiations with manufacturers.

11 Section 4. This legislation will take effect January 1, 2025.

12 Section 5. All laws in conflict with this legislation are hereby declared null and void.
