# A Bill to Make School Districts That Ban Books Ineligible for Federal Grant Opportunities

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	All school districts that permit the banning of books in school libraries are
2		hereafter ineligible to receive funding from federal grants.
3	SECTION 2.	A school district will be defined as a geographical unit for the local
4		administration of schools. Book bans will be defined as any action taken to
5		prohibit the presence of book titles from school libraries (including online
6		programs) based on their content.
7	SECTION 3.	The Department of Education will oversee the enforcement of this bill.
8		A. The Department of Education shall not grant any funding to a school
9		district they deem to be engaging in book banning.
10	SECTION 4.	This legislation will take effect immediately upon passage. All laws in
11		conflict with this legislation are hereby declared null and void.

### **CHSAA 5A State Tournament Session 1 Bill B**

### **The Minor Medical Confidentiality Act**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	During routine medical appointments, parents will be restricted from staying in
2		the room while a medical professional asks patients aged 13-17 years old
3		questions pertaining to sexual health, sexual identity, and mental health unless
4		the patient gives expressed consent for the parents to be present.
5		The following exceptions will apply:
6		A. This information will remain confidential between the patient and the
7		medical provider unless the patient gives express consent for that
8		information to be shared with parents outside of the appointment setting.
9		B. In cases that would require mandatory reporting to outside agencies for
10		abuse, neglect, etc., the medical provider will be able to share that
11		confidential information for the safety of the patient.
12	SECTION 2.	Medical professionals are defined as any doctor, physician's assistant, nurse,
13		nurse practitioner, or other licensed or registered practitioner of medicine who
14		is responsible for direct patient care.
15	SECTION 3.	The Department of Health and Human Services in connection with state
16		medical licensing boards will oversee the implementation of this legislation. A
17		federal-level database will be created to track reported violations.
18		A. First violation: A recorded warning with a fine of up to \$500 paid by the
19		medical provider.
20		B. Second violation: An investigation into reported violations and a fine of up
21		to \$1000 paid by the medical provider.
22		C. Third violation: A 6 month suspension of any licenses or credentials for the
23		medical provider.
24		D. Fourth violation: Revocation of any liscenses or credentials for the medical
25		provider.
26	SECTION 4.	This legislation will take effect on January 1, 2025. All laws in conflict with this
27		legislation are hereby declared null and void.

# A Bill to end cash bail to ensure a safe and equitable pretrial process

1.	BE IT ENACT	ED BY THE CONGRESS HERE ASSEMBLED THAT:
2.	SECTION 1.	Cash bail as a condition of pretrial release will be outlawed in
3.		all federal and state courts in the United States. Judges must
4.		either release defendants on their own recognizance or
5.		provide a non-monetary avenue to ensure their appearance
6.		in court.
7.	SECTION 2.	Judicial discretion in setting bail will be maintained for those
8.		charged with violent felonies and certain non-violent felonies
9.		such as sex offenses and witness tampering.
10.	SECTION 3.	This legislation will be enforced by the Department of Justice.
