A Resolution to Encourage the US Navy to Increase its Presence in South China Sea to Defend Our Allies

1	WHEREAS,	China has rapidly become one of the foremost military powers; and
2	WHEREAS,	It has dominated American allies with its naval superiority in the South
3		China Sea; and
4	WHEREAS,	The United States has continued to abandon its support and commitment
5		to defend democracy worldwide; and
6	WHEREAS,	Regional democratic allies of the United States, including Taiwan and
7		Indonesia, continue to ask for American influence and
8		military support to combat China's aggressive expansion; now, therefore
9		be it
10	RESOLVED,	That the Congress here assembled recommend the United States Navy
11		increase its presence in the South China Sea to deter China's influence

A Bill to Phase Out All Federal Farm Subsidies

1.	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:		
2.	SECTION 1.	All programs that provide direct subsidies or indirect support	
3.		to farm businesses will be phased out over the next five years.	
4.	SECTION 2.	The following definitions apply:	
5.	A. Farm	subsidies are any and all funds paid to farmers to protect from	
6.	price	fluctuations or paid to subsidize insurance, land	
7.	impro	ovements, loans, marketing, research, or export sales.	
8.	B. All 15	0 such programs currently funded by the Department of	
9.	Agriculture are to be eliminated.		
10.	SECTION 3.	The US Department of Agriculture will develop and introduce	
11.		a plan for phasing out all programs. The Government	
12.		Accountability Office will provide a report each year for the	
13.		next five years analyzing the progress toward full elimination	
14.		of all programs.	
15.	SECTION 4.	Phase out will begin January 1, 2025, and continue until	
16.		December 31, 2029.	
17.	SECTION 5.	All laws in conflict with this legislation are hereby declared null	
18.		and void.

A Resolution to Support Additional U.S. Military Action in Yemen

1.	WHEREAS,	The Yemeni Civil War has escalated further with Houthi
2.		rebels attacking American military ships and international
3.		commerce in the Red Sea and Indian Ocean; and
4.	WHEREAS,	The United States has so far chosen to undertake only
5.		limited military operations such as air strikes and not
6.		actively involve itself in the war, but recent continued
7.		actions of Houthi aggression cannot be ignored and must
8.		be answered; and
9.	WHEREAS,	The current situation is unlikely to improve, and the
10.		conditions are being perpetuated by the lack of resistance
11.		to the Houthis' actions; and
12.	WHEREAS,	The people of the region are desperately in need of any
13.		and all aid, in particular military aid, to prevent further
14.		escalation; now, therefore be it
15.	RESOLVED,	By the Congress here assembled that the United States of
16.		America shall undertake additional military actions against
17.		the Houthis to prevent further attacks by them and to
18.		protect both its own military forces and international
19.		commerce; and, be it
20.	FURTHER RE	SOLVED, By the Congress here assembled that the United
21.		States of America encourages other nations to collaborate
22.		with them to help put an end to the Yemeni Civil War.

A Bill to Cap the Price of Insulin to Protect Diabetic Americans

1.	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:			
2.	SECTION 1.	All pharmaceutical companies, pharmacies, carriers, and		
3.		sellers that provide coverage for valid prescription insulin		
4.		drugs shall cap the total amount that a person is required to		
5.		pay out of pocket for all covered valid prescription insulin		
6.		drugs at an amount not to exceed \$25 per the person's entire		
7.		thirty-day supply of insulin, regardless of the amount or type of		
8.		insulin needed to fill the person's valid prescription or the		
9.		number of valid prescriptions.		
10.	SECTION 2.	The following definitions apply:		
11.	A. "Phar	rmaceutical companies, pharmacies, carriers, and sellers" are		
12.	defined as persons licensed by a State to practice pharmacy,			
13.	includ	ding the dispensing and selling of prescription drugs.		
14.	B. "Insul	in drugs" are defined as any pharmaceutical preparation of		
15.	the p	rotein hormone insulin that is used to treat high blood glucose.		
16.	C. "Valid	d prescription" is defined as a prescription that is issued for a		
17.	legitimate medical purpose in the usual course of professional			
18.	pract	ice by a practitioner who has conducted at least 1 in-person		
19.	medi	cal evaluation of the patient; or a covering practitioner.		
20.	SECTION 3.	The Department of Health and Human Services and the		
21.		Department of Commerce will oversee implementation of this		
22.		bill.		
23.	SECTION 4.	This legislation will take effect on January 1, 2024.		
24.	SECTION 5.	All laws in conflict with this legislation are hereby declared null		
25.		and void.

- 2. **SECTION 1.** The Guantanamo Bay Detention Camp will be destroyed in
- 3. Cuba due to its cruel treatment of prisoners.
- 4. **SECTION 2.** The following definitions apply:
- 5. **A.** Guantanamo Bay Detention camp will be defined as a United
- 6. States military prison within the Guantanamo Bay Naval Base in
- 7. Cuba.
- 8. B. Cruel and unusual treatment shall be defined as a punishment
- 9. significantly harsher than punishments traditionally given for the
- 10. same or similar crimes.
- 11. **SECTION 3.** The United States Department of the Army will oversee this
- 12. legislation and decommission of the prison.
- 13. A. The United States Department of Defense shall allocate \$400 Million
- 14. for the funding necessary to make the legislation effective.
- 15. **B.** This money will be used for travel, equipment, the transportation of
- 16. prisoners to new prisons and upgrade of US based detention
- 17. facilities.
- 18. **SECTION 4.** This legislation will take effect on March 1, 2025.
- 19. **SECTION 5.** All laws in conflict with this legislation are hereby declared null
- 20. and void.
