

## **A Resolution to End the Use of Direct-to-Consumer Genetic Testing Services in Criminal Investigations**

- 1   **WHEREAS,**   Law enforcement often uses direct-to-consumer (DTC) genetic testing  
2                   service results in criminal investigations; and
- 3   **WHEREAS,**   The unwarranted use of DTC genetic testing service results constitutes a  
4                   violation of health privacy rights for over 26 million Americans; and
- 5   **WHEREAS,**   Under the Supreme Court ruling in *Griswold v. Connecticut*, a person has  
6                   the Constitutional right to privacy including bodily autonomy which  
7                   includes the right to their own DNA and genetics; and
- 8   **WHEREAS,**   The Fourth Amendment requires law enforcement to obtain a warrant  
9                   prior to conducting a search; now, therefore, be it
- 10 **RESOLVED,**   That the Congress here assembled require law enforcement to obtain a  
11                   search warrant prior to conducting DNA searches through DTC genetic  
12                   testing services; and, be it
- 13 **FURTHER RESOLVED,** That the warrant applies only to the DNA of a specific individual for  
14                   which law enforcement has successfully proven probable cause.

# Geothermal Fracking Initiative Act of 2025

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   Congress finds that Geothermal Fracking (GF) represents a promising and  
2                   renewable source of clean energy and thus authorizes the creation of the  
3                   Geothermal Fracking Initiative (GFI).
- 4   **SECTION 2.**   Geothermal Fracking is defined as the process by which fluids are pumped  
5                   deep beneath the earth's surface to fracture rocks, through which water is  
6                   circulated and heated for the purpose of creating electricity.
- 7   **SECTION 3.**   The Department of Energy shall oversee the implementation of this bill.
- 8                   A. The initial budget for the GFI shall be \$2 billion. All money allocated for  
9                   the initial disbursement shall be disbursed by January 1, 2027.
- 10                  B. Private companies may apply for grants from the GFI to drill GF  
11                  exploratory wells and to develop drilling infrastructure and physical  
12                  energy plant infrastructure.
- 13                  C. Companies applying for grants from the GFI must certify that the  
14                  proposed wells do not pose a significant threat to native ecosystems.
- 15                  D. Companies applying for grants from the GFI must demonstrate that  
16                  energy plants using water from GF wells are likely to be financially  
17                  solvent within ten years of the projected completion of the first GF  
18                  well.
- 19                  E. Every two years, Congress shall review the effectiveness of the GFI in  
20                  increasing energy production using GF and shall either disband the GFI  
21                  or authorize additional funding for the GFI.
- 22   **SECTION 4.**   This legislation will take effect on January 1, 2025.
- 23   **SECTION 5.**   All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Free Non-Commercial Academic Research

- 1   **WHEREAS,**   subscriptions to academic journals are often too expensive for even the  
2                   most well-endowed universities to afford; and
- 3   **WHEREAS,**   research vetting can be carried out by academics without the involvement  
4                   of journal publishers; and
- 5   **WHEREAS,**   physical publishing has become increasingly rare, rendering proprietary  
6                   scientific journals obsolete; and
- 7   **WHEREAS,**   most research funding derives from the public via government grants and  
8                   should therefore be available to the public; and
- 9   **WHEREAS,**   it is currently difficult for third-world countries to afford access to research  
10                  at all, including life-saving medical research; and
- 11   **WHEREAS,**   copyright slows the pace of science by often forcing researchers to navigate  
12                  complex library systems to access research; now, therefore, be it
- 13   **RESOLVED,**   that the Congress here assembled abolishes copyright restrictions on all  
14                  non-commercial peer-reviewed academic research.

## **A Resolution to Limit Property Purchases to Reduce Rent Prices**

- 1   **WHEREAS,**   Throughout the United States rent prices have gone up significantly over  
2                   the past decade; and
- 3   **WHEREAS,**   Over half the renters are unable to pay the rent without exceeding the  
4                   recommended 30% mark according to Harvard's Joint Center for Housing  
5                   Studies; which leads to low-income individuals being unable to afford rent  
6                   and other necessities; and
- 7   **WHEREAS,**   High rent prices are caused primarily by private equity firms that are (but  
8                   not limited to) Blackrock, and Blackstone and their monopoly on the  
9                   market; and
- 10 **WHEREAS,**   These private equity firms make the conditions of renting worse as well as  
11                  increasing rent prices; now, therefore, be it
- 12 **RESOLVED,**   That the Congress here assembled make the following recommendation for  
13                  fixing rent prices; and, be it that investment companies' purchasing power  
14                  and amount are limited.

# A Bill to Federally Regulate Cryptocurrencies

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1     **SECTION 1.**     This Congress finds that cryptocurrency volatility and regulation gaps have caused scams
- 2                         and environmental harm, necessitating protective measures.
- 3     **SECTION 2.**     The following measures shall be taken:
- 4                         A.   Prohibit cryptocurrencies as legal payment tender unless pegged to the U.S. dollar.
- 5                         B.   Impose a 10% tax on crypto profits for environmental damage.
- 6                         C.   Create a "Crypto Permit" for personal traders, requiring SEC approval.
- 7                         D.   Mandate KYC and AML for decentralized exchanges and ATMs.
- 8                         E.   Terminate all mixer services that conceal transaction details.
- 9                         F.   Allocate a total of \$250 million to the SEC for blockchain analytics software and
- 10                        auditing cryptocurrency transactions.
- 11    **SECTION 3.**     The following instruments should be defined as stated:
- 12                        A.   "Cryptocurrency": Digital currency secured by cryptography, excluding U.S.
- 13                        dollar-pegged ones
- 14                        B.   "Crypto Permit": Federal authorization for personal traders to legally trade and mine,
- 15                        subject to SEC approval
- 16                        C.   "KYC" (Know Your Customer): Process to verify client identities and prevent fraud
- 17                        D.   "AML" (Anti-Money Laundering): Regulations to prevent financial crimes, including
- 18                        money laundering
- 19                        E.   "Mixer services": Platforms that obscure transaction histories
- 20                        F.   "Blockchain analytics software": Tools for analyzing blockchain transactions and
- 21                        enhancing transparency
- 22    **SECTION 4.**     The SEC will oversee the enforcement of this legislation.
- 23                        A.   The IRS will enforce environmental taxes on crypto mining and enhance blockchain
- 24                        analytics and audit capabilities.
- 25                        B.   FinCEN will monitor KYC and AML compliance for decentralized exchanges and crypto
- 26                        ATMs.
- 27                        C.   The Department of Justice (DOJ) will help close mixer services.
- 28    **SECTION 5.**     This legislation will take effect in FY 2026.
- 29    **SECTION 6.**     All laws in conflict with this legislation are hereby declared null and void.

# **A Bill to Increase Congressional Salaries**

1. BE IT ENACTED by the Senate and House of Representatives of the United States of
2.                   America in Congress assembled, that:
3. Section 1: The per annum salaries of elected members of the United States House of
4.                   Representatives and the United States Senate will be increased from \$174,000 to
5.                   \$250,000.
7. Section 2: No law enforcement would be necessary. The Department of Human Resources is
8.                   responsible for making sure the raises take effect.
9. Section 3: All funding necessary for the payment of the annual congressional salaries shall be
10.                  allocated as part of that year's defense budget.
11. Section 4: This will go into effect January 3, 2027 at the start of that year's congressional
12.                  session.
13. Section 5: All current laws in conflict with the new law are null and void.

# A Bill to Exempt Cash Tips from Federal Income Taxes to Raise Working Wages

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   The United States will amend the Internal Revenue Code of 1986 to provide  
2                   that tips shall not be subject to income or employment taxes. This policy  
3                   will be targeted towards adjusting the salary of wage working and  
4                   low-income constituents.
- 5   **SECTION 2.**   A. The Internal Revenue Code of 1986 (part VII of subchapter B of chapter  
6                   1) will be amended to allow taxpayers to claim a 100% deduction at filing  
7                   for cash tips.  
8                   B. “Cash Tips” will be defined as gratuity payments in the form of cash,  
9                   credit and debit card charges, and checks that are intended to reward  
10                  services provided by wageworkers.
- 11 **SECTION 3.**   A. The Secretary of the Treasury will oversee the implementation of this  
12                   legislation along with the specific enforcement mechanism.  
13                  B. The Internal Revenue Service will be responsible for providing the 100%  
14                  tax deduction for cash tips.
- 15 **SECTION 4.**   This legislation will take effect in FY 2026. All laws in conflict with this  
16                   legislation are hereby declared null and void.

# A Bill to Remove Troops from South Korea

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1   **SECTION 1.**   The United States will withdraw all its remaining military personnel from
- 2                   South Korea effective immediately. Military support will still be available for
- 3                   South Korean use, if needed.
- 4   **SECTION 2.**   Military support shall be defined as military aid and US military operations
- 5                   in conjunction with South Korean forces.
- 6   **SECTION 3.**   The Department of Defense (DoD) and the US Department of State will
- 7                   oversee implementation of this legislation.
- 8                   A. The US Department of State will authorize distribution of military aid if
- 9                   needed.
- 10                  B. The US Department of State will conduct yearly audits to ensure proper
- 11                  use of military aid, if distributed.
- 12                  C. US military operations shall not be offensive, except in the case of
- 13                  aggression from South Korean adversaries such as North Korea, China
- 14                  and Russia.
- 15   **SECTION 4.**   This legislation will take effect in FY 2025. All laws in conflict with this
- 16                   legislation 15 are hereby declared null and void.



## **A Resolution Concerning Light Pollution**

1. Whereas, bright lights during the night disrupt natural circadian rhythms, and
2. Whereas, the aforementioned disruption is linked with lack of sleep, and
3. Whereas, a lack of sleep can cause car accidents, heart problems, and shorter tempers;  
and
4. Whereas, light pollution harms aerial navigation, and
5. Whereas, light pollution hurts wildlife, and
6. Whereas, light pollution diminishes the beauty of the sky, and
7. Whereas, light pollution hinders celestial observation, therefore
8. BE IT RESOLVED in this student congress, that light pollution should be minimized by
9. means of requiring full cutoff of private outdoor light fixtures with the exception of
10. construction, emergency, and aerial navigational lights, and
11. ALSO BE IT RESOLVED in this student congress, that public outdoor light fixtures over
12. two-thousand and one hundred lumens must be turned off between midnight and
13. sunrise by means of automatic timer with the exception of construction, emergency,
14. and aerial navigational lights.
