# **EVENT REMINDERS**

The *By Laws* and *Standing Rules* of Florida Forensic League, Inc. shall govern the operation of this event. All coaches and students are responsible for reviewing the rules in the *Governing Documents*. Questions about rules should be addressed to the President, who serves as the Tournament Director for the State Championship.

All Events:

# **Laptop Computers**

The use of laptop computers shall be permitted in all debate events at all FFL-sanctioned Events during the 2024-2025 season. During debate rounds, access to or use of e-mail, instant messaging, or other means of receiving information from sources inside or outside the "competition room" are prohibited. (This does not prohibit non-electronic communication between debate partners during prep time.) Contestants found to have violated the provisions above may face the following actions: forfeit the round of competition and receive zero points or disqualification from the tournament and forfeiture of all rounds.

<u>Availability of Evidence</u>: The FFL will be following the NSDA Rules regarding evidence in debate events.

# Rules in A Nutshell – Regarding Evidence

- Debaters are responsible for the validity of all evidence they introduce in the debate.
- Evidence must be provided orally or written and must include the primary author(s) and year of publication. Any other information, such as qualifications, etc. may be given but not required.
- Judges are responsible for resolving disputes between debaters both oral and written sources.
- Judge decisions may not be appealed unless the judge misapplied, misinterpreted, or ignored the rule.
- EVIDENCE CHALLENGES DO NOT GUARANTEE A DECISION REVERSAL
- If you need further clarification, please see the NSDA Evidence Rule as posted on FFL.

Extemporaneous speaking competitors will be permitted to use the internet at all

<u>FFL-sanctioned tournaments</u> when internet access is publicly available. Publicly available is defined as Wi-Fi internet access being available to all students competing, or all competitors will have access to desktop computers with internet availability. In the event that internet access cannot be made available to all competitors, contestants shall be prohibited from the use of any electronic retrieval system (recording or information retrieval system) now known or to be invented during any round in any event at any FFL-sanctioned tournament including the Extemporaneous Speaking preparation room(s), except that electric or electronic devices that are incapable of sending or receiving information between persons may be used for the sole purpose of keeping time.

The League will make accommodations for students with disabilities regarding the use of technology. Documentation of the disability must be provided ten days before the Regional Tournament and State Tournaments. The documentation must be available for review by the Executive Board.

*Policy Debate:* Prep time is 8 minutes per team. The tournament will use the 2024-2025 National Topic.

Resolved: The United States federal government should significantly strengthen its protection of domestic intellectual property rights in copyrights, patents, and/or trademarks.

*Lincoln Douglas:* Prep time is 4 minutes per debater. The tournament will use the NSDA March/April topic.

Student Congress: Each participant to the State Championship may submit one (1) piece of legislation for the agenda. Legislation must follow FFL format (see FFL Congress Manual, Appendix B for details) and emailed as a Microsoft Word attachment to Chris Sprouse thechairhighlyfrowns@gmail.com). Legislation that is not properly formatted, not submitted as a Microsoft Word attachment, or not received by the deadline will not be placed on the agenda. *Speech Events:* Please remember that a copy of each student's script/oration and proof of publication, when applicable, should be brought to the tournament in case of protest. <u>Script information must be available on www.speechwire.com</u>.

# Make All Fees Payable To: FLORIDA FORENSIC LEAGUE

Student Fee = \$50.00 per student (includes awards ceremony meal)

(TD/PF/Duo count as 2; WSD = # of students in group;

double entries only count as 1)

Judge/Coach/Observer Awards Ceremony Meal = \$20.00 per person - entrance tickets will be required for the Awards Ceremony & Dinner in the Pegasus Ballroom

# PENALTY FEES

Drops until 5pm on Friday, February 21st forfeiture of entry fee

Drops 5pm Friday, Feb. 21st - 5pm Wednesday, Feb. 26th: forfeiture of entry fee + \$20.00 drop fee

From 5pm Wednesday, February 26th to the start of the tournament, NO CHANGES will be accepted. This window will be used for travel, e-registration, and fee re-calculation. Any changes submitted during this window will be IGNORED and must be reported via e-registration on Thursday, February 27th.

Drops after 5pm Wednesday, February 26th –10am Thursday, February 27th: forfeiture of entry

fee + \$40.00 drop fee

Drops made after 10am Thursday, February 27th: forfeiture of entry

fee + \$50.00 drop fee

Unreported drop discovered at the tournament: forfeiture of entry

fee + \$75.00 drop fee

Yes, these drop fees are punitive. Drops, especially those just before the tournament, interfere with our ability to run an on-time event.

Judge changes after 5pm on Wednesday, February 26<sup>th</sup> \$25.00 per change

Missed judge calls: \$50.00 per instance

At the State Championship Tournament, judge drops at registration will require the requisite number of students dropped from the tournament. Hidden judge drops at the State Championship Tournament will incur a \$1000.00 fine plus the \$50 fine per round they were assigned and missed.

SCHOOLS MUST COVER THEIR JUDGE OBLIGATIONS - THERE WILL BE NO OFFER OF HIRED JUDGES AT THE TOURNAMENT THIS YEAR

#### **DEBATE JUDGE CHANGES**

In the event that a school changes or drops a judge after the strike sheet for debate has been published, the school making the change shall be required to pay a <u>FINE of \$1000</u> OR DROP THE REQUISITE NUMBER OF STUDENTS/TEAMS. We cannot run a tournament without judges.

JUDGES - This Is TBD - We are consulting Ben from SpeechWire on the feasibility of integrating the Google Forms we used last year into Speech

Coaches will be required to complete a judge ranking form for every judge representing their team. We already have a Google Form set up for the Speech Pool and Debate will soon follow. You may revisit the form and edit it as needed. You can currently complete up to 3 judge ratings per form,

Failure to complete the judge rating forms will result in \$25 fine per instance.

JUDGING - FFL will not offer any judge hires for schools - schools must cover all obligations

# JUDGE OBLIGATIONS

Policy Debate: 1 judge for every 2 teams or fraction thereof; Policy

judges must submit a judge philosophy via SpeechWire website by Friday, February 23rd

Lincoln Douglas Debate: 1 judge for every 2 debaters or fraction thereof; LD

judges must submit a judge philosophy via SpeechWire website by Friday, February 23rd

Public Forum Debate: 1 judge for every 2 teams or fraction thereof; PFD

judges must submit a judge philosophy via SpeechWire website by Friday, February 23rd

Speech/IE/Congress 1 judge for every 5 entries or fraction thereof; A Duo

team counts as 1 entry; double-entered students count as 2. All schools are required to designate 1 judge who can judge Student Congress, even if the

school has no Congress Entries.

# ALL SCHOOLS MUST DESIGNATE 1 JUDGE THAT CAN JUDGE WORLD SCHOOLS DEBATE, EVEN IF THE SCHOOL DOES NOT QUALIFY A WORLD SCHOOLS TEAM. THE SAME APPLIES FOR STUDENT CONGRESS.

Each school's judge quota will be determined on the <u>speechwire.com</u> registration website. The Board of Directors asks that <u>all</u> coaches make themselves available to adjudicate out rounds.

# Judges are obligated for the duration of the tournament. No judges will be dismissed early.

#### **ENTOURAGE RULE**

The Entourage Rule states that individuals who provide coaching or research support for participants in the Policy, PFD, LD, or Congressional Debate must fulfill certain obligations as judges. Specifically:

- 1. For Policy, PFD, LD: Coaches or research support individuals must be entered in the judge pool for a minimum of two rounds. They should also be available to judge elimination debates.
- 2. For Congressional Debate: Coaches or research support individuals must be entered as judges and be available for elimination debates.

Note - If there is a valid reason why someone requires an exception to these obligations, they should contact the tournament administrator before the tournament to seek approval (Brian McAninch - <a href="mailto:flforensicleaguecommunications@gmail.com">flforensicleaguecommunications@gmail.com</a>)

The consequences for violating the Entourage Rule are as follows:

- 1. Policy, LD, and PFD: They will lose their strikes (if offered).
- 2. Schools with Congressional Debaters: They will be fined the fee for an uncovered judge (\$300).

NOTE: As a result of the 2006 voting, the governing documents now contain this under Rule 4 (Judging Responsibilities) – Letter L: Any coach in or out of the judge pool that refuses or fails to pick up an elimination round ballot, his/her school shall be fined \$50.00 and the school of the person who judges the round shall be credited \$25.00.

#### LEAGUE SEEKS DEBATE JUDGES FOR HIRE

FFL uses additional fees charged to Policy Debate teams for the purpose of hiring experienced judges who will enrich the quality of the TD judge pool. Interested parties should contact FFL Vice President Brian McAninch (<u>flforensicleaguecommunications@gmail.com</u>) before February 12<sup>th</sup>, 2025.

#### CONDUCT OF PARTICIPANTS

Coaches, judges, other observing adults, contestants, and student observers shall comply with the rules set forth in the *FFL Civility Code*, which is available for download at <a href="https://floridaforensicsleague.com/">https://floridaforensicsleague.com/</a>. Please review this document with all participants from your school. It was updated this calendar year and can be found on the FFL Website. Coaches will be asked to sign a form either prior to or at registration acknowledging the FFL Civility Code and attest that they understand and that they have shared the information with their students, judges, chaperones, and observers.

# FFL PROPERTY PROTECTION POLICIES

In the fall of 2005, FFL member schools voted to establish anti-vandalism measures. All coaches should read Standing Rule 19 and share its contents with their students, which include:

- 1. No contestant or student observer shall enter or remain in a contest room without a judge present. The penalty for violation of this regulation shall be immediate disqualification.
- 2. Vandalism of property by any person at an FFL tournament shall result in immediate notification of school and/or local police authorities. The Board of Directors shall notify the principal of the school associated with the vandal(s) in writing and insist upon appropriate remuneration. In the case of vandalism by a contestant, the additional penalty of immediate disqualification from the tournament shall also apply.

FEE PAYMENT - Schools that have a five-year track record of prompt fee payments MAY be permitted to send fees in advance to speed up the registration process. Schools lacking a minimum five-year history of timely payments for all tournaments WILL NOT be permitted to pay by mail. If payment is mailed, a purchase order, proof of mailing, or another form of documentation must be provided to the treasurer for record-keeping at registration and electronically. Details regarding mailing and eligibility decisions will be managed by FFL Treasurer Grant Chmielewski, who can be contacted at <a href="mailto:Grant.Chmielewski@ocps.net">Grant.Chmielewski@ocps.net</a>.

In other words if you wish to mail your fees FFL Treasurer Grant Chmielewski must give you written approval. If your bookkeeper for example has mailed fees to Legacy HS or to Apopka or anywhere else other than to Grant at Dr. Phillips HS you will not qualify to mail your fees.

Please make sure that you put in your check request with enough time for your bookkeeper to cut your check.

### **REGISTRATION**

Registration will be held at <u>HOLIDAY INN EXPRESS & SUITES ORLANDO EAST – UCF</u> on Friday, February 28th, 2025 after 4:15 PM until 10:00PM. Registration that occurs after this time will incur a fine of \$100 because it places an undue burden on getting competition started in the morning as we navigate Open State. Please note:

- 1. The purpose of this registration is to make final payment and confirm entries. It is not a place to change judge names. That information should be communicated via email to Carol Cecil at flforensicleague@gmail.com . There are still penalties for drops and name changes made via email, but they are less than the day of tournament changes.
- 2. Registration should be conducted by the Head Coach or Assistant Coach for the member school. If those individuals are not available, an adult proxy may complete registration. However, that person must be able to answer all questions about a school's entry. Students will not be permitted to register for a school or be present in the registration area.
- 3. Schools not registered by a time to be determined will be dropped from the tournament.
- 4. Make all fees payable to FLORIDA FORENSIC LEAGUE.
