Hello Coaches, Competitors, and Judges!

Welcome to the 6th season of the OATS (Online Asynchronous Tournament Series). Last year almost 90 teams competed at the six regular season tournaments (averaging about 50 teams per tournament), and we look forward to seeing so many of our friends again this season.

The OATS financial situation continues to be strong, so we are happy to announce that we are able to maintain the tournament series fee to \$200 for the 25-26 season. We will maintain a \$10/uncovered slot fee, and we will continue the fee waivers for student-run teams or those experiencing financial hardship. Look for a financial report from the 2024-2025 season on the Outspoken Culture website.

We will use multiple communication tools throughout the season. Outspoken Culture will continue using is an accounting software called Zoho Books. You will receive receipts through Zoho Books, so you may need to check your junk email box to locate receipts for payments. You can also expect emails to coaches and judges on Monday evening as well as additional email and social media communication throughout each tournament week.

Entries and Links Due to Speechwire by Monday of Tournament Week @ 8 p.m. CST

OATS tournaments will be hosted exclusively on Speechwire. All entries must be submitted by 8 p.m. CST on Monday of the tournament week. Fees will be assessed by 10 p.m. CST that evening. The entry must include the video for the student competing in the event, including both required videos for LP competitors.

In the occurrence where videos are not viewable by 10 p.m. CST on Monday evening, the tournament may grant an emergency extension until 8 a.m. CST the following morning. If the video is not viewable by that time, the slot will be dropped (fees will remain as assessed the previous day).

Novice Competitors

Teams are encouraged to denote novices when registering for the tournament. For the purposes of the OATS, novice competitors include students who have not competed in intercollegiate speech competitions prior to the current speech season.

Video Submission

We require all video submission links be put forward through some sort of streaming platform like YouTube. Set the video to "unlisted" for the duration of the tournament. Following judging, we want students to have control over the visibility of the performances, so students may turn the videos to "private" or delete the videos from the platform after the awards ceremony on Friday.

We ask that each submitted performance video recording has not been entered into a previous asynchronous tournament. We believe teams will act honorably and submit a fresh, unique performance video made exclusively for that tournament.

Content Warnings

To continue work done regionally and nationally, we will continue providing a space to input content warnings for pieces. If a student's performance includes sensitive topic areas they anticipate may be triggering for audience members or judges, we ask you to enter those topics into the content warning space on Speechwire at the time you submit your entries AND in the video description of the recording itself (e.g., in the title, video description). Students do not have access to the same information judges have, so adding the content warning to the video itself means while students view final round video links, they will have access to the content warnings.

Judging

Judges will complete preliminary round evaluations from Tuesday morning through 4 p.m. CST Thursday. Judges will complete final round evaluations from 6 p.m. CST Thursday through 2 p.m. CST Friday. All ballots and scores must be completed by the deadlines, or schools will be charged a dropped/no show judge fee. Each event will be reviewed by at least three (3) judges (in accordance with AFA qualification bylaws).

Semifinal Rounds

In the event of a category going to semifinals, an altered schedule will be released to accommodate those particular categories.

Dropped Judge Fee

The dropped/no show judge fee is \$50.

Single Team Affiliation

Unless there is an extreme circumstance, judges will not be allowed to judge for more than one team at a tournament. Judges are also not allowed to judge on behalf of a team AND to serve as a hired judge for the tournament. While the asynchronous tournament mechanism allows for this to happen, will not permit this to occur without an outstanding reason.

Late Adds and Drops

No slot adds will be allowed after the event registration closes. Considering the asynchronous format, we don't anticipate any drops or changes for Individual events, as the complete video will be uploaded with the slot registration by Monday at 8:00 p.m. CST (including LP).

***If you have outstanding fees from a previous season, you must pay these outstanding fees before you can register for the 25-26 season.**

All 11 Categories Offered

All 11 categories will be offered using [ASC/OATS guidelines for competition](#). Videos must not be edited to enhance visual or audio quality for a competitive advantage; videos must be one take without "special effects". Audiences may be present during the filming of performances.

Limited Preparation

Prompts for LP will be posted on Speechwire at noon CST on the Friday before the tournament entry deadline. For instance, if entries to a tournament are due Monday, September 30, the LP Prompts will be released Friday, September 27 at noon CST.

Recording Videos

Students will submit two videos. Video 1 will be judged during Prelim 1, Video 2 will be judge during Prelim 2, and Video 1 will be judged during finals. Impromptu prompts will be quotations from marginalized groups. Extemp questions will be Prelim: Domestic, Finals: International.

Preparation Time

We trust all students and coaches to adhere to Limited Prep guidelines and ethical competition choices for preparation. Extemp prep does not need to be included in the performance video. However, please include prep time in Impromptu videos (this can make starting the video camera easier for students, and assessing time allocation possible for judging).

Video Recording Errors

While uncommon, occasionally a student's recorded video for an LP category faces technical difficulty (e.g., sound doesn't work, video cuts off halfway through, etc). Unlike in other categories where a student could re-record the performance, that option is not available for LP students as re-recording the same speech negate the educational value of the genre. If such a technical difficulty occurs, please contact the tournament staff immediately. The student will be provided an opportunity to record with a different prompt provided by the tournament. While this is not the ideal situation, we wish to focus on the student's educational opportunities.

Sweeps awards are earned using the following point system:

Prelim Sweeps Points		Finals Sweeps Points	
1 st Place: 3 points	*non-advancing semi-	1 st Place: 10 points	4 th Place: 4 points
2 nd Place: 2 points	finalists will earn 2	2 nd Place: 8 points	5 th Place: 3 points

*The only instance when an OATS tournament would go to semi-finals is in the event a category exceeded 50 entries. If a category exceeds 50 entries, an altered schedule will be released to coaches, judges, and competitors.

The awards ceremony will honor

- ≡ The top novice in each category (where applicable)
- ≡ Final round competitors
- ≡ Top 5 competitors in individual sweeps
- ≡ Top 5 teams in team sweeps

Teams will be forwarded a folder of award images suitable for printing or posting to social media platforms.

Name Pronunciation

Being called by your correctly pronounced name creates an inclusive, welcoming, respectful space. To aid judges and awards readers, please provide student name pronunciation through Speechwire.

Integrity Pledge

One of the biggest things we miss from asynchronous tournaments is students watching other performances. OATS tournaments will allow individuals to watch final round videos after signing an Integrity Pledge. The Integrity Pledge declares that the individual watching the video will act in an ethical manner. After signing the Pledge, individuals will receive video links to the final rounds when finals are posted. A link to the Integrity Pledge will be posted on Speechwire and sent to coaches. A new Pledge must be signed for each tournament.

Judge Integrity Pledge

Coaches and students value high-quality feedback. Therefore, we request all judges complete the Judge Integrity Pledge prior to completing judging responsibilities for the tournament. The Judge Integrity Pledge must be signed once during the OATS season.

Accessibility

Nationally, the forensic community (students, coaches, and judges) have called for safer tournaments where student and judge wellness is built into the tournament structures. At OATS tournaments, we hope to provide more accessible spaces, even in the online format.

Entering Accommodations in Speechwire

OATS staff are grateful for the open and clear communication coaches have with us regarding accommodation notifications for students. While we do share these notifications with judges, we wish to further increase communication clarity with judges as they fill out ballots. To that end, we invite coaches to enter student accommodation notifications in the CW section (or the "topics") section during registration. This will ensure judges receive the accommodation notification directly at the time of judging the round.

This is a new practice at the OATS, so please feel free to share feedback with tab staff on ways we can continue to improve accessibility.

Open Door Policy

OATS tournament staff acknowledge the art of performance may be a healing process and/or an opportunity to speak on important, personal topics. As a performer, it is impossible to know all the ways in which content or a performance may unintentionally harm or trigger members of your audience. To better serve the wellness of the forensic community, we will be using an open door practice for this tournament.

Judges will be evaluating potentially triggering performances within their home spaces. This means we need to take even more steps to protect their well-being. We strongly urge teams to include content warnings, and if a judge feels concerned about the triggering nature of performances in the assigned round, tournament staff will adjust the judging requirements.

Student-Run Team Hosting Fundraiser Opportunity

Student-run teams face different challenges than teams with coaches and staff. One major issue can be finding and maintaining funding. In an effort to support these students, OATS is offering a chance to co-host tournaments as a \$500 fundraiser for student-run teams. Hired Judging Staff for OATS Tournaments

OATS tournament hosts will provide judges for the tournament. Judges for OATS tournament will consist primarily of forensic alums and friends of the program. If a notable percentage of judges originate from an unexpected origin (e.g., a large contingent of graduate teaching assistants with limited speech experience), the tournament staff will alert participating teams. Individuals interested in serving as a hired judge for the OATS should contact tournament staff.
