A Bill to Encourage the Appointment of Nonpartisan Supreme Court Justices

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. **SECTION 1**. The current simple majority vote required within the senate to appoint a
- 3. Nominated Justice by the President to the Supreme Court will hereby be
- 4. changed to a two-thirds majority.
- 5. **SECTION 2**. Definitions: "Nominated Justice" is a candidate chosen by the President
- 6. to fill a Supreme Court Vacancy.
- 7. **SECTION 3**. This change will be overseen and executed by the Senate Rules
- 8. Committee and the Committee on the Judiciary.
- 9. **SECTION 4**. This legislation will take effect immediately upon passage.
- 10. **SECTION 5**. All laws in conflict with this legislation are hereby null and void.

A Resolution to Adopt a Nuclear No-First-Use Policy to Decrease the Threat of Nuclear War

- 1. WHEREAS, At a time where competitors such as Russia and China are actively
- 2. seeking to fortify and modernize their nuclear arsenals in response to perceived risk
- 3. from the United States; and
- 4. WHEREAS, Current geopolitical tensions combined with a renewed reliance on
- 5. nuclear weapons and the collapse of nuclear arms control make the risk of accidental
- 6. launch based on a miscalculation increasingly high; and
- 7. WHEREAS, Aggressive posturing towards Russia and China erodes the confidence
- 8. building measures that are the foundation of good nuclear stewardship; and
- 9. WHEREAS, A no-first-use policy would drastically decrease the risk of nuclear war
- 10. by promoting diplomacy, reassuring countries such as Russia and China, and
- 11. decreasing the risk of miscalculation; now, therefore, be it
- 12. **RESOLVED**, By the Congress here assembled that the United States should adopt
- 13. a global nuclear no-first-use policy; and, be it
- 14. FURTHER RESOLVED, That this nuclear no-first-use policy should be declared
- 15. publicly and multilaterally by the United States and its allies.

A Bill to Ban Police Use of Facial Recognition Technology

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. **SECTION 1**. All state, local, and federal law enforcement agencies are hereby
- 3. prohibited from utilizing facial recognition technology.
- 4. **SECTION 2**. Facial recognition technology shall be defined as any technology
- 5. utilizing landmarking methodology for feature extraction. This includes skin texture
- 6. analysis, thermal cameras, or any other biometric authentication in software capable
- 7. of identifying or verifying information about a person's physical characteristics.
- 8. **SECTION 3**. The Department of Justice will be responsible for enforcement of the
- 9. law, and agencies non-compliant with law shall be subject to repercussions. Data
- 10. collected using facial recognition technology can no longer be utilized to
- 11. meet probable cause standards or be brought up as evidence before a jury.
- 12. **SECTION 4**. The bill goes into effect January 1st, 2026.
- 13. **SECTION 5**. All laws in conflict with this legislation are hereby null and void.

A Bill to Ban Former Congressmen from being Lobbyists to "Close the Revolving Door"

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. No former member of Congress shall engage in any form of lobbying.
- 3 **SECTION 2**. A lobbyist shall be defined as a compensated individual who
- 4 communicates with a public office holder with the intent to influence
- 5 legislative or executive action.
- 6 **SECTION 3**. The United States Department of Justice shall oversee the 7 implementation of this bill.
- 8 A. Former members of Congress who violate this legislation will face up
- 9 to \$100,000 in fines and up to 5 years in prison.
- 10 B. The United States Social Security Administration shall withhold the
- 11 pension of any former member of Congress who violates this legislation.
- 12 **SECTION 4**. This legislation will take effect on January 1st, 2026.
- 13 **SECTION 5**. All laws in conflict with this legislation are hereby null and void.

A Bill to End the Sale of Offensive Military Weapons to Ukraine

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. **SECTION 1**. The United States will cease all sales of offensive military weapons to
- 3. Ukraine.
- 4. **SECTION 2**. Definitions: "Offensive military weapons" shall be defined as weapons
- 5. primarily designed for use in initiating or escalating military conflict, including but not
- 6. limited to tanks, fighter jets, missile systems, and assault weapons.
- 7. **SECTION 3**. The Department of State, in conjunction with the Department of
- 8. Defense, will oversee the enforcement of this legislation. Any contracts currently in
- 9. negotiation or execution for the sale of offensive military weapons will be reviewed
- 10. and terminated if they conflict with the provisions of this bill. Violations by private
- 11. contractors or defense companies will result in penalties including fines and
- 12. revocation of government contracts.
- 13. **SECTION 4**. This legislation will take effect on January 1st, 2026.
- 14. **SECTION 5**. All laws in conflict with this legislation are hereby null and void.

A Bill to Omit Misdemeanors from Criminal Background Checks to Decrease the Rate of Recidivism

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2. **SECTION 1**. The United States Federal Government will expunge misdemeanors
- 3. from criminal background checks in order to decrease the rate of recidivism from
- 4. ex-offenders.
- 5. **SECTION 2**. Definitions:
- 6. A. A misdemeanor is a crime punishable by less than 12 months in jail which can
- 7. result in community service, probation, fines, and imprisonment for less than a
- 8. year are commonly issued punishments for misdemeanors.
- 9. B. A criminal background check is the process of investigating a person's past
- 10. criminal misconduct.
- 11. C. Recidivism refers to a person's relapse into criminal behavior and is measured
- 12. by criminal acts that result in re-arrest, re-conviction, or return to prison
- 13. overseeing the enforcement of the bill.
- 14. **SECTION 3**. This bill will be implemented on January 1st, 2026.
- 15. **SECTION 4**. All laws in conflict with this legislation are hereby null and void.
