A Bill to Federally Regulate Cryptocurrencies

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **Section 1**. This Congress finds that cryptocurrency volatility and regulation gaps have caused 3 scams and environmental harm, necessitating protective measures. The following measures 4 shall be taken: a) prohibit cryptocurrencies as legal payment, b) impose a 10% tax on crypto 5 profits for environmental damage, and c) create a "Crypto Permit" for personal traders, 6 requiring SEC approval.
- 7 **Section 2**. The following terms should be defined as stated: "Cryptocurrency" is a digital 8 currency secured by cryptography and "Crypto Permit" is Federal authorization for personal 9 traders to legally trade and mine, subject to SEC approval.
- 10 **Section 3**. The SEC will oversee the enforcement of this legislation. The IRS will enforce 11 environmental taxes on crypto mining.
- 12 **Section 4**. This legislation will take effect on January 1st, 2027.
- 13 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

The Cuban Sanctions Repeal Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 Section 1. The United States government shall lift all economic sanctions on the country of
- 3 Cuba. Furthermore, the United States Government shall engage in foreign relations with Cuba
- 4 to achieve and maintain the goal of open trade and borders between one another.
- 5 **Section 2**. The definitions for this act are as follows: The Office of the United States Trade
- 6 Representative shall be abbreviated if necessary to "The USTR."
- 7 **Section 3**. The United States Congress shall oversee the repealing of the current economic
- 8 sanctions. The USTR shall be tasked with foreign relations with Cuba to achieve the goals 9 stated in Section 1.
- 10 **Section 4**. This act shall go into effect 90 days after passage.
- 11 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

The Geothermal Fracking Initiative Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 Section 1. Congress finds that Geothermal Fracking (GF) represents a promising and
- 3 renewable source of clean energy and thus authorizes the creation of the Geothermal
- 4 Fracking Initiative (GFI).
- 5 Section 2. Geothermal Fracking is defined as the process by which fluids are pumped deep
- 6 beneath the earth's surface to fracture rocks, through which water is circulated and heated for 7 the purpose of creating electricity.
- 8 **Section 3**. The Department of Energy shall oversee the implementation of this bill. The initial
- 9 budget for the GFI shall be \$2 billion. Private companies may apply for grants from the GFI to
- 10 drill GF exploratory wells and to develop drilling infrastructure and physical energy plant
- 11 infrastructure. Companies applying for grants from the GFI must certify that the proposed
- 12 wells do not pose a significant threat to native ecosystems.
- 13 **Section 4**. This legislation will take effect on January 1st, 2026.
- 14 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Replace the Federal Income Tax with a Fair Tax

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 **Section 1**. The United States Federal Income Tax will be replaced by a consumption tax 3 model called The Fair Tax.
- 4 **Section 2**. The Fair Tax would replace the federal individual income tax, corporate income 5 tax, payroll tax, estate and gift taxes with a national sales tax.
- 6 **Section 3**. Taxpayers will receive a monthly "pre-bate" for the cost of sales tax on necessities 7 up to the federal poverty level.
- 8 **Section 4**. This legislation will take effect on January 1st, 2027.
- 9 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Mitigate Stand-Your-Ground Laws

- 2 Section 1. The United States Federal Government will withhold all federal funding for public
- 3 safety agencies from states who have expanded stand-your-ground laws beyond the defense
- 4 of the home until such time as those laws are repealed.
- 5 Section 2. Stand-Your-Ground laws will be defined as the castle doctrine's premise of self-
- 6 defense in one's own home. Public safety agencies will be defined as a government agency
- 7 that is responsible for the protection and well-being of the public, including law enforcement,
- 8 fire protection, and medical assistance.
- 9 Section 3. The Department of Justice shall oversee the implementation of this bill.
- 10 **Section 4**. This legislation will take effect on January 1st, 2026.
- 11 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

- 4 companies and hackers targeting those companies.
- 5 **Section 2**. "User Data" will be defined as name, age, political party, gender, purchasing
- 6 preferences, location, and other personal information.
- 7 Section 3. The Federal Communications Commission (FCC) shall oversee the
- 8 implementation and enforcement of this bill.
- 9 Section 4. This legislation will take effect on January 1st, 2027.
- 10 Section 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Prohibit Gambling Advertisements in Sports Media

- 3 **SECTION 2**. "Gambling advertisement" shall refer to the promotion of activities including
- 4 casinos, lotteries, online betting platforms, and sportsbooks.
- 5. "Sports media" shall refer to all visual and audio forms of broadcasting, streaming, or
- 6 reporting related to sports, including television, radio, and online content based in the United 7 States.
- 8 **SECTION 3**. The Federal Communications Commission (FCC) and the Federal Trade
- 9 Commission (FTC) shall be responsible for enforcing this legislation and penalizing 10 violations
- 11 **SECTION 4**. This legislation shall take effect 90 days after passage.
- 12 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Create Refugee Status for Venezuelan Migrants

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2 Section 1. The United States shall establish a specific refugee status for Venezuelan migrants
- 3 fleeing political persecution, violence, or economic hardship, granting them a pathway to
- 4 permanent residency.
- 5 **Section 2**. "Refugee status" shall refer to a protected immigration status allowing Venezuelan
- 6 migrants to reside and work in the United States legally. "Venezuelan migrants" shall refer to
- 7 individuals who are nationals of Venezuela or habitual residents of Venezuela seeking asylum
- 8 due to documented risks of persecution or other significant hardships.
- 9 Section 3. The Department of US Immigrations and Customs Enforcement (ICE) and the U.S.
- 10 Citizenship and Immigration Services (USCIS) will oversee enforcement of this legislation.
- 11 **Section 4**. This legislation will take effect on January 1st, 2026.
- 12 **Section 5**. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to End the Use of Direct-to-Consumer Genetic Testing Services in Criminal Investigations

- 1 WHEREAS, Law enforcement often uses direct-to-consumer (DTC) genetic testing service
- 2 results in criminal investigations; and
- 3 WHEREAS, The unwarranted use of DTC genetic testing service results constitutes a
- 4 violation of health privacy rights for over 26 million Americans; and
- 5 WHEREAS, Under the Supreme Court ruling in Griswold v. Connecticut, a person has the
- 6 Constitutional right to privacy including bodily autonomy which includes the right to their own 7 DNA and genetics; and
- 8 **WHEREAS**, The Fourth Amendment requires law enforcement to obtain a warrant prior to 9 conducting a search; now, therefore, be it
- 10 **RESOLVED**, That the Congress here assembled require that law enforcement obtain a 11 search warrant prior to conducting DNA searches through DTC genetic testing services.

- 5 exonerated, their sentences to be terminated immediately, and their records expunged of
- 6 criminality related to this law. Any ongoing investigations and trials into violation of The
- 7 Espionage Act shall also be terminated immediately.
- 8 **SECTION 3**. This legislation shall be overseen by the Department of Justice.
- 9 **SECTION 4**. This legislation shall take effect immediately upon passage.
- 10 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Limit Annual College Tuition Price Increases

- 3 annual tuition price increases to no greater than the year-over-year inflation
- 4 rate to address the student debt crisis. Colleges that raise tuition prices
- 5 above the predetermined amount will lose the benefits of their tax-exempt status.
- 6 **SECTION 2**. Benefits of tax-exempt status shall include access to tax-
- 7 deductible donations, tax-free infrastructure projects, and minimal tax 8 payments.
- 9 **SECTION 3**. The Department of Education will be responsible for overseeing
- 10 the implementation and enforcement of this bill. Congress must vote to
- 11 increase tuition fees if it exceeds the current year-over-year inflation rate.
- 12 **SECTION 4**. This legislation will take effect immediately.
- 13 **SECTION 5**. All laws in conflict with this legislation are hereby declared null and void.
