# Bill A: A Bill to Ban Domestic Flights on Private Jets to Reduce Carbon Emissions

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 **SECTION 1.** The use of private jets to fly across or inside the United States' skies will be  
2 terminated and severely punished. The liberty of commercial jets will be  
3 maintained as the status quo.

4 **SECTION 2.** There is a distinction between the two types of jets:

5 A. Private jets shall be defined as aircraft used for individual/company needs  
6 to transfer individuals from one place to another.

7 B. Commercial jets shall be defined as aircraft designed as necessary only for  
8 the transportation of approved passengers or cargo aircraft designed as  
9 necessary only for the transportation of approved passengers or cargo.  
10 Flights using these jets will not be banned.

11 **SECTION 3.** The Federal Aviation Administration (FAA) will oversee the enforcement of  
12 this bill

13 A. The sale of private jets for personal use shall be prohibited.

14 Additionally, the manufacturing of new private jets within the United  
15 States or by domestic firms shall be forbidden.

16 B. If the offense is violated, a minimum criminal penalty of 10 years with  
17 a \$7 million fine will be imposed. In addition to the criminal penalties,  
18 the offending aircraft may be seized and repurposed for public or cargo  
19 use.

20 **SECTION 4.** This legislation will take effect on June 25th, 2026 . All laws in conflict with  
21 this legislation are hereby declared null and void.

# Bill B

## **A Bill to provide Universal Healthcare for all to Improve American Medical Coverage**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All United States citizens shall be provided universal healthcare.

SECTION 2. Universal healthcare shall be defined as healthcare all citizens will have access to and not be charged for.

SECTION 3. The department of health and human services will be responsible for the implementation of this legislation.

SECTION 4. This legislation will take effect on January 1, 2026 All laws in conflict with this legislation are hereby declared null and void.

# Bill C

## **A Bill to Increase the National Driving Age to 18**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. To reduce the frequency of fatal accidents, The United States Congress  
3 shall increase the minimum legal age to obtain a permit to drive from 16 years old  
4 to 18 years old.

5 SECTION 2. A national driving age shall be defined as the minimum legal age limit  
6 required to get any permit (including learning permits) to drive in the United States.

7 SECTION 3. The Department of Transportation shall oversee the implementation of  
8 this legislation. States voluntarily adopting the new legal national driving age limit  
9 shall be eligible for a financial incentive, the specific amount will be decided by the  
10 Department of Justice based on state population size and implementation plans.

11 SECTION 4. This legislation will take effect on January 1, 2027.

12 SECTION 5. All laws in conflict with this legislation are hereby null and void.

## Bill D

# **A Bill to Strengthen Gun Control Laws to Enhance Public Safety**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. All individuals must undergo a comprehensive federal background check  
3 and complete a certified gun safety course prior to purchasing any firearm in the  
4 United States.

5 SECTION 2.

6 A. A comprehensive federal background check shall include mental health history,  
7 criminal history, and domestic violence records.

8 B. A certified gun safety course shall include safe handling, storage practices, and  
9 legal responsibilities.

10 SECTION 3. The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) shall  
11 oversee the enforcement and implementation of this legislation.

12 SECTION 4. This legislation will take effect on July 1, 2026. All laws in conflict with  
13 this legislation are hereby declared null and void.

## Bill E

# **A Bill to Expand the Use of Nuclear Power to Promote Clean Energy and Reduce Carbon Emissions**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States shall increase investment in the development and  
3 construction of nuclear power plants as a means to reduce carbon emissions and  
4 promote clean, reliable energy.

5 SECTION 2.

6 A. Nuclear power shall be defined as energy produced through controlled nuclear  
7 reactions, including both fission and emerging fusion technologies.

8 B. Federal funding shall be allocated to research, development, and regulatory  
9 oversight of nuclear energy projects.

10 SECTION 3. The Department of Energy, in coordination with the Nuclear Regulatory  
11 Commission, shall be responsible for the implementation and oversight of this  
12 legislation.

13 SECTION 4. This legislation will take effect on January 1, 2026. All laws in conflict  
14 with this legislation are hereby declared null and void.

# Bill F

## **A Bill to Mandate Paid Maternity Leave**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States shall mandate at least 18 weeks of paid maternity  
3 leave for all employees following the birth or adoption of a child.

4 SECTION 2.

5 A. Paid maternity leave shall be defined as a job-protected leave of absence with  
6 continued wage compensation at no less than 66% of the employee's regular pay.

7 B. Eligible employees shall be entitled to no less than eighteen (18) weeks of paid  
8 maternity leave per childbirth or adoption event.

9 C. Employers may not terminate or discriminate against employees for taking such  
10 leave.

11 SECTION 3. The Department of Labor shall be responsible for the implementation,  
12 enforcement, and oversight of this legislation, including the development of  
13 reporting procedures and compliance audits.

14 SECTION 4. This legislation shall take effect on July 1, 2026. All laws in conflict  
15 with this legislation are hereby declared null and void.

# Bill G

## A Bill to Restrict Oil Consumption

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States shall reduce national oil consumption by 25% over the  
3 next ten years through regulatory restrictions, incentives, and investment in renewable  
4 energy alternatives.

5 SECTION 2.

6 A. Oil consumption shall be defined as the use of petroleum-based fuels for  
7 transportation, heating, electricity generation, and industrial production.

8 B. A phased reduction shall occur, requiring a 2.5% annual decrease in oil consumption  
9 beginning January 1, 2026.

10 C. The sale of new gasoline-only passenger vehicles shall be prohibited starting in 2032.

11 D. Federal subsidies for oil exploration and drilling shall be eliminated by 2028.

12 E. Incentives and tax credits shall be provided for renewable energy adoption,  
13 including solar, wind, and electric vehicle infrastructure.

14 SECTION 3. The Department of Energy, in coordination with the Environmental  
15 Protection Agency and Department of Transportation, shall oversee implementation,  
16 enforcement, and annual reporting on national oil consumption metrics.

17 SECTION 4. This legislation shall take effect on January 1, 2026. All laws in conflict  
18 with this legislation are hereby declared null and void.

# Bill H

## A Bill to Prevent Overfishing

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States shall implement stricter regulations on commercial and  
3 recreational fishing to prevent overfishing and ensure the long-term sustainability of marine  
ecosystems.

4 SECTION 2.

5 A. Overfishing shall be defined as the removal of a species of fish from a body of water  
6 at a rate that the species cannot replenish, resulting in population decline.

7 B. Annual catch limits (ACLs) shall be reduced by 20% for all federally managed fish stocks  
8 currently listed as overfished or subject to overfishing.

9 C. A mandatory seasonal moratorium shall be established for at-risk species during peak  
spawning periods.

10 D. All commercial fishing vessels shall be required to install real-time tracking and  
catch-reporting systems

11 by January 1, 2027.

12 E. Violations of catch limits or moratoriums shall result in escalating fines and potential  
license suspension.

13 SECTION 3. The National Oceanic and Atmospheric Administration (NOAA) and the  
14 National Marine Fisheries Service (NMFS) shall be responsible for implementing, monitoring,  
and

15 enforcing the provisions of this legislation, including regular stock assessments and public  
reporting.

16 SECTION 4. This legislation shall take effect on January 1, 2026. All laws in conflict  
17 with this legislation are hereby declared null and void.

# **Bill I**

## **A Bill to Mandate Public Schools to Implement a Four Day School Week**

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The United States shall make all public school weeks Monday through  
3 Thursday. Each individual state will decide how to designate the rest of the required time  
4 based on their own education requirements.

5 SECTION 2. Public schools shall be defined as schools, educating children, that receive  
6 federal funding from the United States Government.

7 SECTION 3. The oversight of this bill will be the United States Department of Education. All  
8 public schools found in defiance of this legislation will lose federal funding until they are in  
9 compliance.

10 SECTION 4. This legislation shall take effect on January 1, 2026. All laws in conflict  
11 with this legislation are hereby declared null and void.
