Entry Fees

- Base Team Entry Fee: \$20.00
- IE NFA Speech Entry: \$8.00 per entry
- Late Entry Drop Fee: \$10.00 (On/After 10pm EST 11/11)

Judge Fees

- Uncovered Judge Fee: \$20.00 per uncovered judge
- Late Judge Drop Fee: \$10.00 (On/After 8am EST 11/12)

For every 6 entries, 1 judge is required.

Impromptu and Extemp Filming

All events below will have specific files uploaded to the "Files for Download" section on Speechwire no later than 10:00PM on Friday, November 7th, 2025. Only write and film these speeches after these details have been posted!

- <u>Impromptu</u> will consist of a quotation set. Only one speech/performance will be used for both prelims and out rounds.
 - Prep must be included in filming
 - Judges will be asked to allow 15 seconds for a student to read their prompt
 - Honor system for students
- Extemp will consist of a three question set. Only one speech/performance will be used for both prelims and out rounds.
 - o Prep DOES NOT need to be included in filming
 - Honor system for students

Structure

11 NFA IE events

- 32 entries or less in an event: 2 Preliminary Rounds, 1 Final Round
- 32+ entries in an event: 2 Preliminary Rounds, 1 Semifinal Round, 1 Final Round

Awards and Tiebreakers

Top 6 finalists recognized in Speechwire medal postings ASAP.

- Preliminary tiebreakers: All ranks so far, All reciprocals so far, All speaker pts so far, H2H in prelims (# of first prefs.), Prelim opponents' avg. total ranks
- Out-round tiebreakers: Ranks this round, 1s this round, All ranks so far, Speaker pts this round, Prelim ranks, Drop speaker pts of worst rank, Playoff result
