5		of our nation's students.
6	WHEREAS,	Students that are not exposed to a wide range of issues within the
7		classroom may face unexpected challenges as they near adulthood.
8	WHEREAS,	This governing body owes it to our nation's students to protect their right
9,		to an expansive and enriching education; now, therefore, be it
10	RESOLVED,	That the Congress here assembled pledges to put a stop to the banning of
11		books within the libraries and curriculums of schools in the United States.

### A Bill to Mandate Fiscal Responsibility to Prevent Further Increases in National Debt

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- Section 1. All new mandatory spending legislation, and all tax legislation that would result in a net loss of federal revenue, passed by the US Congress must be offset. Legislation that is not deficit-neutral shall not be brought to a vote, as evaluated by the Congressional Budget Office.
- Section 2. "New mandatory spending" shall be defined as any newly proposed or
  enacted legislation that creates or expands entitlement programs or other
  spending not subject to annual appropriations. "Tax legislation" shall be
  defined as any enacted legislation that alters federal revenue. "Emergency
  spending" shall be defined as capital allocated for purposes of a response
  to a sudden, urgent, and unforeseen event that threatens public health or
  national security.
- Section 3. The Office of Management and Budget shall be responsible for monitoring the implementation of this act and will have a public ledger tracking the impact of all subject legislation.
- Section 4. Spending related to a formal Declaration of War passed by Congress shall be exempt from the mandates in this act.
- Section 5. This legislation will take effect on FY 2027. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Make Enforcement Less Threatening (M.E.L.T)

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States Congress shall pass a law requiring
2	officers in Imr	migration and Customs Enforcement (ICE) to have their faces
3	visible when o	on duty.
4	SECTION 2.	Visible shall be defined as being able to see the entire face
5	from the bott	om of the lips to the top of the forehead and from the left
6	cheek to the r	ight cheek of a person's face. On duty shall be defined as all
7	the time some	eone is working or is required to be ready to work.
8	SECTION 3.	Exemptions to this bill include: officers in approved
9	undercover a	ssignments, officers wearing motorcycle helmets, officers
10	wearing an N	95 medical or surgical mask, officers in extreme weather
11	conditions, of	fficers wearing breathing apparatuses when necessary to
12	protect again	st toxins, gas, and smoke, officers wearing eyewear to protec
13	themselves a	gainst retinal harms.
14	SECTION 4.	If an officer is found to not be in compliance with this and
15	not under any	y of the already listed exemptions, they will be subject to
16	termination.	·
17	SECTION 5.	The legislation will be overseen by the Department of
18	Homeland Se	curity
19	SECTION 6.	This legislation will take effect on January 1, 2026.
20	All laws in cor	nflict with this legislation are hereby declared null and void.



## A Bill to Classify all Individually Wrapped Goods as a Single Serving

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	All individually wrapped goods will be classified as one serving.
2		A. The nutrition label of said good shall reflect this.
3	SECTION 2.	"Individually wrapped good" shall be defined as any food or drink product,
4		regardless of quantity or size, packaged as one item.
5	SECTION 3.	The FDA (Food and Drug Administration) will oversee the enforcement of
6		this bill. Violations of this legislation will be up to the discretion of the FDA.
7	SECTION 4.	This legislation will take effect on January 1st, 2027. All laws in conflict with
8		this legislation are hereby declared null and void.

# A Bill to Regulate the Purchase and Expenditure of Cryptocurrencies

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Under the passage of this legislation, the United States Federal government		
2		will receive the authority to regulate the purchase and expenditure of		
3		cryptocurrencies within the United States.		
4	SECTION 2.	To be able to regulate cryptocurrencies, the United States Federal		
5		Government will be given the power to restrict the purchasing of certain		
6		cryptocurrencies, limit the transference of the cryptocurrencies, and		
7		monitor transactions.		
8	SECTION 3.	The Securities and Exchange Commission oversees securities exchanges,		
9		securities brokers and dealers, investment advisors, and mutual funds to		
10		prevent fraud, thus, due to experience in such responsibilities, it will be		
11		enforcing this law.		
12		A. This is a national law that all states must follow.		
13		B. Illegal trading of cryptocurrencies will result in fines of upwards of		
14		\$100,000. Repeating offenders might face a prison sentence of upwards		
15		of 20 years.		
16	SECTION 4.	This legislation will take effect on November 1, 2025.		
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Provide Free Mental Health Care To All U.S. Residents

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** All 50 States shall provide free mental health care to all U.S. residents ages 13 and up based on need.

- 5 **SECTION 2.** Let mental health care be defined as:
- 6 i. Psychotherapy–talk therapy from a licensed therapist, including telehealth and in-7 person visits.
- 8 ii. Psychiatry–prescription medications and related mental health visits from a licensed psychiatrist, including telehealth and in-person visits.
- 10 iii. Inpatient mental health care, including rehabilitation, eating disorder treatment, 11 and other traditional causes for admittance.

- 13 **SECTION 3.** Funding will come from restoring and preventing the Medicaid cuts in The
- One Big Beautiful Bill Act (OBBBA), totaling \$1 trillion over the course of 10 years.
- 15 I. Additionally, the Mental Health Parity Regulations section of the bill will be restored.
- 16 II. The Center for Medicare and Medicaid Services will oversee the funding, 17 distribution, and enforcement of this bill.
- 18 **SECTION 4.** This legislation will take effect on October 1, 2026.
- 19 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
