

A Bill to Establish Independent Redistricting Commission to Abolish Gerrymandering

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States hereby establishes an Independent Redistricting Commission in each of the 50 states to redraw congressional districts every 12 years following the U.S. Census Demographic shift. This Independent Restricting Commission will be created by the state.

SECTION 2. A. The Independent Restricting Commission will have its members selected to reflect the state's geographical, racial, gender, and political diversity. The commission will require 8 members, with 2 chosen from the two major political parties respectively, and four independents. Any map will have to pass with eight members in favor of the map to pass.

B. Each state will create its own independent redistricting commission. State legislatures shall only reject the district map if they are found to violate the state Constitution or the Constitution of the United States.

C. The independent commission will be established every 10 years according to the U.S. Census demographic survey.

D. In the case these maps violate the Constitution, redistricting shall be done repeatedly until a map is approved.

SECTION 3. The Federal Election Commission will work alongside states to implement this bill. The Federal Election Commission will intervene if it is observed that there exist any discrepancies in any of the terms listed above.

SECTION 4. This legislation will take effect on January 1, 2027. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Lower Prescription Drug Costs

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1: The United States will enact a markup cap for all prescription drugs.

- A. The United States will cap markup prices by companies at 7% for prescription drugs.
- B. Companies that refuse to follow the legislation will have a federal tax on profits double than the percentage of markup costs.

Section 2: The following definitions apply:

- A. Prescription drugs will be defined as any drug that is obtained with a prescription.
- B. Markup caps will be defined as a method to prevent companies from marking up manufactured products to gain more profit.

Section 3: The Food and Drug Administration along with the Internal Revenue Service will be responsible for the implementation of this bill.

Section 4: This legislation will take effect at the start of FY 2027.

Section 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to Establish an Expanded North American Free Trade Agreement (ENFTA)

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States shall establish an Expanded North American Free Trade Agreement (ENFTA), eliminating all tariffs, quotas, and similar trade barriers among key North American countries, explicitly excluding Cuba.

SECTION 2. “Trade barriers” shall include tariffs, quotas, embargoes, regulatory restrictions, and any non-tariff measures intended to restrict imports or exports. The “Key North American Countries” included in ENFTA shall be Canada, United States, Mexico, Guatemala, Belize, Honduras, El Salvador, Nicaragua, Costa Rica, Panama, Dominican Republic, Haiti, and Jamaica.

SECTION 3. The Office of the United States Trade Representative (USTR) and the Department of Commerce shall oversee enforcement and negotiate terms with participating countries.

- A. The USTR shall publish a progress report every six months detailing negotiations and compliance status.
- B. ENFTA shall enter into force upon ratification through bilateral or multilateral written agreements between all participating countries listed in Section 2.
- C. ENFTA shall replace and supersede previous trade agreements immediately upon its enforcement.

SECTION 4. This legislation will take effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Sports Betting

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

SECTION 1. All sports betting is hereby prohibited anywhere within the United States and its territories. This includes online betting on any devices located domestically.

SECTION 2. Sports betting shall include any monetary wager with a payout based on any element of a sporting event. This most commonly refers to an event's final score or overall outcome, but other far more minute elements may be bet on as well and would equally be prohibited under this legislation.

SECTION 3. Any establishment or website that is found to have permitted sports betting on its premises/webspace shall be fined \$10,000 per infraction. Should any individual establishment or website accrue more than ten (10) violations in a period of twelve (12) months or fewer, it shall be stripped of any and all operational licensing for a period of no less than three (3) years. Individuals engaging in sports betting shall not be punished.

SECTION 4. This legislation shall be overseen by the Federal Trade Commission (FTC) with the support of the Federal Bureau of Investigations (FBI) for enforcement purposes.

SECTION 5. This legislation shall take effect immediately upon passage.

SECTION 6. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Make Federal Jury Service Voluntary

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

SECTION 1. Henceforth, federal juries shall be filled by volunteers only.

SECTION 2. District courts may still contact citizens to entreat them to serve as jurors, but those who do not want to serve may simply ignore these solicitations. The federal judiciary is encouraged to increase incentives for jury service if they find it necessary to do so.

SECTION 3. States and territories are encouraged to enact similar legislation as soon as is practicable.

SECTION 4. This legislation shall take effect immediately upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Promote Montessori Education Models

WHEREAS Maria Montessori's pioneering educational insights and innovations are still benefiting educators over seven decades after her death; and

WHEREAS Many studies have revealed the enormous advantages of the Montessori method for students of all ages and grade levels; and

WHEREAS These unique benefits are especially valuable given the current discord and animosity that too often characterize our nation's discourse; now, therefore be it

RESOLVED by the Congress here assembled that schools of all types throughout the country are strongly encouraged to adopt the Montessori Method, in whole or in part; and be it

FURTHER RESOLVED that Congress encourages local Departments of Education to fund programs at schools both public and private that support this transition, in particular for older grade levels that have been less likely to utilize this method previously.
