State Festival Re-Registration/Confirmation

These coach instructions pertain only to the State Festival, once districts have been completed.

Re-registration deadline (and last date for changes) and a link to the SpeechWire page to do this is published at www.whsfa.org/state-speech. **All** schools must log in, and at minimum, update judges, and confirm entries. If your school will not participate, please contact us.



After logging in to SpeechWire, you should be directed to the State Festival home page. If not, click the **WHSFA**

State Speech Festival icon. You will see your timeslot reservation, highlighted in yellow. Your first step to confirm is to click Update your entries. If you are missing entries you believe have advanced, contact office@whsfa.org.



Otherwise, drop any entries who are unable to participate. Be sure to click "Update entries" to save.

Next click "Enter or update your judges" or "Update your judges." The judge page will be empty; you add a number of certified judges as required by the number of entries you are bringing:

- 1-8 entries = 1 judge Uncovered judge are \$200/each.
- 9-19 entries = 2 judge
- 20+ entries = 3 judge

Judges are scheduled the same time their school participates. The number needed, based on entry

2 judges are required to cover your 9 entries in the tournament.
You are currently being charged \$200.00 for 1 missing judge.

count, displays in the "Judge requirements" section. If you are below the required number, a red message informs you how much you are being charged for uncovered (missing) judges. This will automatically add to your invoice, unless you change the number, and add names. To <u>add judges</u>, please type a number and click the "Add judges" button. Then, type the names of judges in the table under "Manage judges" and click "Save changes."

Special Needs & Scheduling Requests

If you have students or judges with special needs or scheduling requests, click "Enter special needs." Each special need should be a separate entry (individuals with multiple needs should have multiple entries). Please ONLY use this to suggest accommodations/modifications judges will need to make. At the State Festival we do not provide food, so dietary restrictions do not need to be entered.

For **scheduling requests**, you may request for a student to **present** early (i.e., they have to leave campus early because of a conflict). Please be judicious in these kinds of requests. If every coach requests for all their students to present early, we can't accommodate that; however, we'd rather you request through SpeechWire than to instruct students to ask adjudicators directly to perform early.

If you must request for a particular entry to present during a *different time slot*, please indicate the school employee/background-checked adult who is a certified adjudicator who will serve during that alternative time slot.




Next, "Return to tournament home page" and then click WHSFA logo icon, "Confirm entries." If you provided a cell phone number when

initially registering, it should be here; otherwise, please provide one, so we can find you on the Madison campus in the event of an emergency. Then, agree to the statement that certifies the accuracy of your judges' and contestants' information, as well as contestant eligibility as per your school/district policies, and click the button, "Submit confirmation."

After returning to the registration home page, click "View your entries," which allows you to double-check entries and judges. You can return to SpeechWire as many times as needed before the deadline and make changes to your registration. We understand conflicts arise in students' schedules, and you may need to change judges.



From the registration home page, click "Current invoice" to see fees owed, and even print a copy (see the button, "Print this invoice") to furnish to your school bookkeeper. After the deadline, the State Office will generate final invoices based upon registration at that time, which will be emailed to you. Individual entries are \$10; 2-person Demonstration entries are \$12; group entries are \$15.

The week after the deadline, you will receive an email with a final invoice, as well as a confirmation of entries. We also will email you a "contestant itinerary" that shows which rooms your students will present in. Please share contestant room assignments with students (and any parents coming to watch) prior to arriving on campus.
